

Andy Satterfield is the contact for this project. No substitutions will be allowed. All equipment is to be delivered F.O.B. freight paid with inside delivery to this location.

Quantity of 101 Glock Model 42 handgun- Caliber 380

- The pistol frame shall be polymer.
- The slide shall be steel construction with a matte black finish.
- The sights consistent with factory standard polymer white-dot front and white bracket rear.
- The external surfaces of the pistol shall be of a durable dark and matte, non-glare finish.
- Equipped with 2 (two) standard Glock 42 magazines.

Warranty:

Guns furnished under any award resulting from this bid shall be covered by the most favorable commercial warranties given to any customer for such a weapon and the rights and remedies provided therein.

Manuals:
