Subject: Standard Purchasing Resolution 2 – Glock Handguns – Police Department

History

- Troy Police Department is currently issued .40 caliber Glock duty handguns that were purchased in 2005.
- In 2014, the Department purchased .380 caliber Glock handguns to serve as a small sized concealable back-up weapon to increase officer safety.
- Also, in 2014 a study was published by the FBI concluding that the 9MM Glock handgun is recommended for law enforcement use. The FBI noted that the smaller and lighter weight round allows for greater accuracy, additional rounds available per magazine, and meets the ballistic standard for law enforcement use.
- The Department's current duty handguns are approximately 14 years old and are beginning to show some mechanical failures. When these issues occur, the weapons are taken out of service until they can be repaired and inspected by a certified armorer.
- In an effort to maintain the highest quality equipment recommended, the Police Department is seeking to replace both the .40 caliber Glock handguns and .380 caliber Glock back-up weapons with the FBI recommended 9MM Glock handguns.

Purchasing

- On August 23, 2018; a bid opening was conducted as required by City Charter/Code and bid proposals were received at the City's request from firms interested in providing Glock Handguns for the City of Troy Police Department.
- Companies were notified via the Michigan Intergovernmental Trade Network (MITN); www.mitn.info. 60 vendors were notified via the MITN website.
- Three (3) bid responses were received. Below is a detailed summary of the vendor responses.

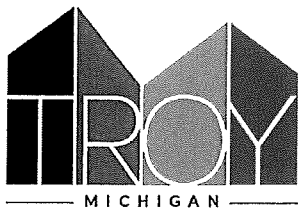

MITN provides a resourceful online platform to streamline the procurement process, reduce costs, and make it easier and more transparent for vendors to do business with the City of Troy.

Active MITN members with a current membership and paying annual dues receive automatic electronic notification which allows instant access to Bids, RFPS and Quote opportunities with the City.

Active MITN non-paying members are responsible to monitor and check the MITN website for opportunities to do business with the City.

Inactive MITN member status can occur when a company does not renew their account upon expiration. Inactive members cannot be notified of solicitations or access any bid information.

Purchasing

- The total cost of the 9MM Glock handguns includes a trade-in value for the current .40 caliber and .380 caliber Glock handguns along with ammunition the department will no longer need.
- *Michigan Police Equipment Company of Charlotte, MI* is the low bidder meeting specifications for the 9MM Glock handguns, sights, and magazines for an estimated amount of \$119,952.50.
- *Michigan Police Equipment Company* also offered the most advantageous trade in value for the Department's current Glock handguns, magazines, and ammunition in the estimated total of \$107,580.00.
- The difference between the estimated bid prices and the estimated trade-in value is \$12,372.50.
- Therefore for approximately \$12,372.50, the Police department will be able to purchase:
 - 155 Glock 9MM Duty handguns
 - 115 Glock 9MM back-up concealable handguns
 - 270 Trijicon HD night sights for all of the purchased handguns
 - 200 Glock Duty magazines
 - 50 Glock back-up handgun magazines
 - Less trade-ins as specified
- The estimation of trade in value is contingent on condition of the equipment being traded in and may slightly change the final total cost of the new handguns.
- A detailed description of value, weapons specifications, and quantities are detailed in the attached bid summary.

Financial

Funds are available in the 2018/2019 Training Operations Budget for the Handgun replacement.

Recommendation

City Management recommends awarding a contract to the low bidder meeting specifications; *Michigan Police Equipment Company of Charlotte, MI* to supply the Police Department with the Replacement Glock Duty Weapons, sights and magazines for an estimated total amount of \$119,952.50, less estimated trade-in value of \$107,580.00 for an estimated total final cost of \$12,372.50
