Subject: Standard Purchasing Resolution 2 – Award to Low Bidder Meeting Specifications – Gun Holsters and Lights– Police Department

### History-

- Troy Police Department is currently using the Black Hawk Level III Serpa Holster and Blawk Hawk Xiphos NTx Weapon mounted lights (180 lumens) for the Officer’s duty handguns.
- Both pieces of equipment are approximately nine (9) years old.
- The current holster has been the focus of studies that show issues of:
  - Inability to draw the weapon - when debris (dirt, snow, or mud) gets lodged in the safety release, the officer will not be able to draw the weapon out of the holster.
  - Accidental discharges - The safety release button is in line with the trigger finger which had been linked to accidental discharges when drawing the weapon.
  - Banned on Federal shooting ranges - Due to the above issues the holster has been banned on all federal ranges limiting training opportunities for Troy officers.
- In an effort to maintain officer safety and protection of citizens; the Police Department is seeking to replace the current holster with the Safariland Model 7360 & TS ALS/SLA holster and replace the current weapon mounted light with the Surefire x300 (1000 Lumens).
  - The proposed holster will maintain weapon security while eliminating the issues of failure to draw malfunction and potential for accidental discharge.
  - The current weapon mounted light is showing its age and beginning to malfunction.
  - Better LED technology has drastically increased Lumen capability and battery life.

### Purchasing

- On February 21, 2019; a bid opening was conducted as required by City Charter/Code and bid proposals were received at the City’s request from firms interested in providing Gun Holsters and Lights for the City of Troy Police Department.
- Companies were notified via the Michigan Intergovernmental Trade Network (MITN); [www.mitn.info](http://www.mitn.info). One Hundred and Ninety four (194) vendors were notified via the MITN website.




