



## History

- Patrol rifles have become the standard in law enforcement for situations requiring a response to critical incidents such as active shooters.
- Properly equipped patrol rifles are tactically superior in regards to accuracy and ammunition capability.
- The rifles currently in service are equipped with the minimum basic accessories including factory installed iron sights and only a few have mounted light systems.
- Currently the Troy Police Department has equipped their officers since 2007.
- The rifles are pool weapons which are shared by all officers.
- Troy Police Department currently has (56) Smith & Wesson M&P15 rifles assigned to the Operations Division which are approximately 15 years old and have reached their end of life.
- Troy Police Department is looking to purchase (45) new rifles and trade-in the (56) 15-year-old rifles. Downsized due to the departments individual rifle purchase program.

## Purchasing

On February 18, 2021 a bid opening was conducted as required by City Charter/Code and bid proposals were received at the City's request from firms interested in providing Patrol Rifles for the City of Troy Police Department. Companies were notified via the Michigan Intergovernmental Trade Network (MITN); [www.mitn.info](http://www.mitn.info). 66 vendors were notified via the MITN website. Three (3) bid responses were received. Below is a detailed summary of the vendor responses.
