### **History**

Our current inventory of shotguns is over 20 years old with most being manufactured between 1999 and 2002. Some go back to 1982. Some of the older shotguns went through a rebuilding process in 2004 completed in-house by our department armorers. At this point, the shotguns are beyond their service life. This includes shotguns with worn and loose parts.

We would like to replace our shotguns with less lethal shotguns. Less lethal shotguns would fire a bean bag round as opposed to a live round. Increasing our less lethal options will increase our ability to deescalate potential deadly encounters, save lives, make arrests and keep the peace.

Our Officers have pepper spray in command cars and tasers immediately available to them as less lethal options. But there are limitations with regards to effectiveness and distance. Having a dedicated less lethal shotgun in all patrol cars would give our Officers an immediate less lethal option that can be used from up to 70 feet away.

This purchase would include (53) less lethal shotguns with accessories and ammunition for practice and qualification and trade-in of (65) 20-year-old shotguns.

### **Purchasing**

On September 14, 2023, a bid opening was conducted as required by the City Charter/Code for the purchase of the Mossberg shotguns with attachments, ammunition and trade-in of current shotgun inventory for the Police Department. The bid was posted on the MITN Purchasing Group website; [www.bidnetdirect.com//city-of-troy-mi](http://www.bidnetdirect.com//city-of-troy-mi). Seventy-two (72) vendors were notified via the MITN website. 4 bids were received. The summary of vendor responses is detailed below.

## Financial

Funds are budgeted and available in the Capital Fund for General Police Equipment under Project Number 2024C0010 for the 2024 fiscal year with a total available budget of \$87,000. The expenditures will be charged to Account Number 401.301.11.305.978.010.

## Recommendation
