History

The fire department uses a variety of tools when conducting firefighting efforts. Control of smoke and heat via a flow path is vital to safe firefighting efforts. This is achieved by using fans to create positive pressure ventilation in a structure that allows firefighters a safer path of entry into the building.

Purchasing

On November 9, 2023, a bid opening was conducted as required by City Charter and Code for Portable Ventilation Fans. The bid was posted on the MITN Purchasing Group website; www.bidnetdirect.com//city-of-troy-mi.
