Standard Purchasing Resolution 2: Low Bidder Meeting Specifications - Fire Hose and Ground Ladder Testing

Resolution #2023-11-157-J-4b

RESOLVED, That Troy City Council hereby **AWARDS** a three (3) contract with an option to renew for one (1) additional year to the low bidder meeting specifications, *Waterway Twin Tier LLC, of Newport, RI*, to provide annual fire hose and ground ladder testing services for an estimated total cost of \$21,325 for year 2024, \$22,925 for year 2025, and \$24,525 for year 2026, at unit prices contained in the bid tabulation opened October 26, 2023; not to exceed budgetary limitations, contract expiring December 31, 2027.

BE IT FURTHER RESOLVED, That the award is **CONTINGENT** upon the contractor's submission of properly executed bid and proposal documents, including insurance certificates and all other specified requirements.

After approval of the successful bidder by the Troy City Council, a purchase order will be issued from the City of Troy creating a bilateral contract between the parties, and commit the successful bidder to perform the contract in accordance with specifications. Subject: Standard Purchasing Resolution 2 – Fire Hose and Ground Ladder Testing

History

The Fire Department is required annually to test many pieces of its equipment by the National Fire Protection Association (NFPA). This includes fire hoses and ground ladders. These tests are conducted by certified and trained 3rd party companies.

Purchasing

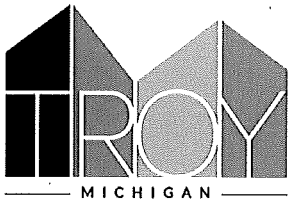
On October 26th, 2023, a bid opening was conducted as required by the City Charter and Code for a three (3) year contract with an option to renew for one (1) additional year for fire hose and ground ladder testing services. The bid was posted on the MITN Purchasing Group website; www.bidnetdirect.com//city-of-troy-mi. Two (2) bid response was received. Below is a detailed summary of potential vendors for the bid opportunity:
