Standard Purchasing Resolution 2 – Fire Hose and Ground Ladder Testing

History

The Fire Department is required annually to test many pieces of its equipment by the National Fire Protection Association (NFPA). This includes fire hoses and ground ladders. These tests are conducted by certified and trained 3rd party companies.

Purchasing

On October 26th, 2023, a bid opening was conducted as required by the City Charter and Code for a three (3) year contract with an option to renew for one (1) additional year for fire hose and ground ladder testing services. The bid was posted on the MITN Purchasing Group website; www.bidnetdirect.com//city-of-troy-mi. Two (2) bid response was received. Inactive MITN member status can occur when a company does not renew their account upon expiration. Inactive members cannot be notified of solicitations or access any bid information.

After reviewing the bid responses, it is recommended that *Waterways Twin Tier, LLC of Newport, RI* be awarded the contract to provide annual fire hose and ground ladder testing services. The testing will be performed in the City of Troy and within the required time frame at unit prices contained in the bid tabulation.

Financial

Funds are budgeted annually in the Fire Department Operating Budget account number 101.336.344.802.070 Contractual Services General. For year 2024, the estimated cost for testing is \$21,325.00; for 2025, the estimated cost is \$22,925.00; and for 2026, the estimated cost is \$24,525.00.
