<u>Investments – Graystone Consulting review of compiled investments for the quarter ending June 30, 2014</u>

Michael Holycross and Brian Green of Graystone Consulting reviewed the consolidated investment report for the guarter ended June 30, 2014.

The review was done in detail noting Total Fund performance for the current quarter of 3.64%, Calendar YTD of 4.69% and Trailing 1, 3, 5 and 10 years. Total market value of assets held at June 30, 2014 were \$212,447,980.

The review included definitions of "Trailing Years" and the consultants answered all questions posed by the Board.

The ERS Board agreed by consensus that the quarterly performance reports met the reporting needs of the Board.

<u>Investments – UBS Consulting review of UBS and NAIC investments ending July 31, 2014 and investment recommendations</u>

Rebecca Sorenson, Darin McBride of UBS Financial Services reviewed the ERS Board and NAIC accounts for the month ending July 31, 2014.

It was noted that the combined UBS investment portfolio allocation was in line with the ERS Investment Policy.

UBS reviewed recommended option transactions. Discussion took place as to the strategy of using options and how it met the Boards conservative approach. Consensus was reached by the Board that it was a recommended approach in re-balancing the portfolio when a reduction equities is required to meet Investment Policy guidelines.

The Board further directed the System Administrator to approve UBS recommended Call and Put options as long as they met the requirements of ERs Rules and Regulations ER-2009-6-26.

Investments - IAS Report - No Sell Rcommendations/Available Cash \$592,745

No action taken.

Other Business - GRS Actuarial Fee Letter

The System Administrator reviewed the fee letter from the Systems actuaries Gabriel, Roeder, Smith & Company noting that additional fees will be incurred for the actuaries to incorporate the requirements of *Governmental Accounting Standards Board* (GASB) *Statement Number 67* "Financial Reporting for Pension Plans – Amendment to GASB Statement 25". Additional fees were estimated at \$2,000 -\$4,000 in the first year of implementation.
