1. **Manzo-Helton, LLC** requests to transfer ownership of 2009 Class C Licensed Business located at 3614 Rochester Road, Troy, MI 48083, Oakland County, from GBD, Inc. and request new Official Permit (Food) & SDM License to be held in conjunction {MLCC #533046}.

Present to answer questions from the Committee were attorney Kelly Allen, Joyce Helton, and Matthew Manzo.

Ms. Allen advised the Committee that Ms. Helton and Mr. Manzo entered into a management agreement with the former owners of Franco's Restaurant in November 2009. The former owner will remain as the executive chef. Ms. Helton and Mr. Manzo have experience in the marketing and financial aspects of the restaurant business. A general manager and two wait staff have been hired and TIPS training has been scheduled. Interior renovations have been completed and the final inspections have been requested.

Officer Feld informed the Committee that Franco's Restaurant received sale to minor violations in 1995, 1998, 2004, and 2008.

2. **Smoker's Express, LLC** requests a New SDM License, to be located at 2981 East Big Beaver Road, Troy, MI 48083, Oakland County. {MLCC Req. #524881}.

Present to answer questions from the Committee was Joseph Harris.

Mr. Harris advised the Committee that he purchased the business, which offers a walk-in humidor and lottery ticket sales, approximately two years ago. After the CVS Pharmacy vacated that shopping center, he has been approached by customers requesting that he sell beer and wine. Mr. Harris is a retired officer from the Detroit Police Department and understands the consequences of sales of tobacco and liquor to minors. He currently has two employees, plans to hire one more, and everyone will be trained. Additional "reach-in" coolers will be purchased for the business. Building and Fire Department approvals have been obtained.

Committee members asked Officer Feld if there is an inventory minimum for SDM licensed businesses. Officer Feld will research the matter.

Officer Feld informed the Committee that the MLCC will review Mr. Harris' probation status for misdemeanor domestic assault prior to giving their approval for the SDM license.

This item does not require Committee action or City Council approval.

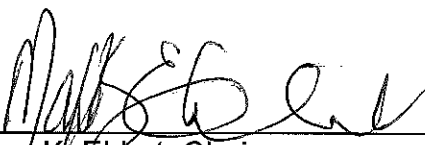
E Mart, LLC

This is the former location of CVS Pharmacy at Dequindre and Big Beaver Roads. Major renovations are planned.

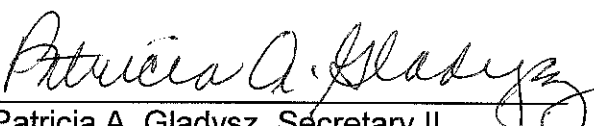
San Marino Club, Inc.
