- B. Report TDDA Plan # 8 2017 Amendments, Approval Update (Presented by Mark Miller, Director of Economic and Community Development)
 - Director Miller updated the Board on the amendments noting that Troy City Council approved the amendments that included the authorization of marketing costs and the QDI program that proposed utilizing 60% of the annual tax increment increase of the target property to be used for public facilities and enhancement and authorized the TDDA the flexibility to adjust the amount of the annual assistance, not to exceed 60% of new investment and its additional tax capture.
- C. Report Planning and Economic Development Update (Presented by Brent Savidant, Planning Director)
 - Planning Director Savidant presented the update and highlighted the 888 Mixed Use Development noting Shake Shack and Fidelity Investment buildings under construction. Zen Apartments receiving preliminary site plan approval.
- D. Report Big Beaver Shuttle Update (Presented by Kurt Bovensiep, Public Works Director and Emily Frontera, Public Works Coordinator)
 - Public Works Director Bovensiep and Public Works Coordinator Fontera presented the update noting local marketing initiatives, ridership use and demographics, and upcoming changes including changes to service times, routes and the inclusion of weekend service.
- E. Report Lights of Hope Update (Presented by Kurt Bovensiep, Public Works Director and Emily Frontera, Public Works Coordinator)
 - Public Works Director Bovensiep and Public Works Coordinator Frontera presented the update noting that lights will illuminate the Big Beaver Corridor median from Coolidge Road to Rochester Road.
- F. Report City Council Resolution, Remove Civic Center from TDDA Plan (Presented by Brian Kischnick, City Manager and Mark Miller, Director of Economic and Community Development)
 - City Manager Kischnick informed the Board that City Council approved a resolution to "Direct" the TDDA to begin the process of removing the Civic Center property from the development plan. After much discussion, the Board directed TDDA management to schedule a special meeting between the TDDA and City Council to further discuss the issue in order to obtain a better understanding of Council's intent.

Trustee MacLeish inquired of the impact to current outstanding bonded debt should the community center property be removed from the TDDA plan. The City Attorney will report back to the Board of any legal implications of the directive related to the current outstanding bonded debt.

H. Report – Town Center Master Plan RFQ – (Presented by Brian Kischnick, City Manager)

City Manager Kischnick informed the TDDA that City Council has suspended and retracted the Town Center Master Plan RFQ.

I. Study Item - Marketing of DDA/Big Beaver - (Facilitated by Alan Kiriluk, Chairman)

Chairman Kiriluk presented support for an initiative to advance the imaging, branding and marketing of the City of Troy on a state, national and international platform in order to attract and retain a talented young labor force and the businesses in need of that labor.

Administrator Miller and City Manager Kischnick acknowledged the need for the initiative but reminded the Board that there is currently no budgeted funding for such a project and expectations for available funding in the near future are low.

Trustee Chamberlain-Creanga expressed her experience in such initiatives and explained that significant progress can be obtained at a low to no cost strategy through the use of public/private partnerships and other partnership building programs.

Chairman Kiriluk encouraged Board members to contact Administrator Miller if they would like to further explore and participate in a group to develop a strategy to further this initiative.
