8. Request for NO PARKING Signs on the South Side of Witherbee between Eton and Graefield

Witherbee and is marked with NO PARKING signs. During construction work in the Pembroke School parking lot, employees were forced to park along Witherbee. Now that the parking lot is completed, they continue to park there. Mrs. Felzer has difficulty backing out of her driveway when vehicles are parked on either side of her driveway on Witherbee.

Lt. McWilliams approves of this request because the road is narrow and can cause difficulty for the school buses also.
