- Recommend that the Road Commission for Oakland County be asked to extend 1. the length of green time at westbound Big Beaver to southbound Adams. (Item 5).
- Recommend that fire lanes/tow away zones shown in the attached sketch be 2. established for the Troy Sports Complex (Item 8).
- Recommend that additional "No Parking" signs on the north and west sides of 3. Balfour and on the north side of Lexington not be installed (Item 7).

Council voted last month to retain the "No Turn on Red" sign for westbound Square Lake at Coolidge. The item was put on the Traffic Committee agenda for September 19th because Mr. Cummings was unable to attend the August meeting. He did not attend the September meeting (Item 4).
