SUBJECT: Traffic Committee Recommendations

At the Traffic Committee Meeting of November 20, 1996, the following recommendations were made for City Council approval:

- 1. Recommend that a temporary "No Right Turn 5-6 p.m." sign be installed on Coolidge at Derby, on a 90-day trial basis. City of Birmingham officials should be notified before the sign is installed (Item 4).
- 2. Recommend that parking not be allowed on Butterfield during construction as requested by Kirco Inc. (Item 5).
- 3. Recommend no change in existing traffic control devices at Edith and Gulliver. (Item 6).
- 4. Recommend no change in existing parking regulations on Ramblewood (Item 7).
- 5. Recommend that a traffic signal not be installed on Livernois at Royaldale (Item 8).
- 6. Recommend no change in existing traffic signal timing plan for the traffic signal at the intersection of Golfview and Coolidge (Item 9).

SUBJECT:

Traffic Committee Recommendations Regarding Sec. 30 Traffic Concerns

At the November 20th Traffic Committee meeting, the Committee recommended installation of a temporary "No Right Turn 5-6 PM" sign on Coolidge at Derby. It is strongly felt that this may create more problems to the traffic in the area rather than solving them. Such a sign may alleviate traffic problems on Derby, but due to this turn restriction the existing traffic may be diverted to Glouchester and other neighboring roads, causing a mushrooming effect on the existing traffic problems. On November 21st this office received a concern from a citizen with residence on Derby Road, who felt this sign should not be installed since he will have no easy access to his residence and will have to travel 12 more minutes on the neighborhood roads to get to his residence from work.

Besides this, since Derby is on the Troy-Birmingham border, it will be more appropriate to implement any traffic mitigation measures in conjunction with the concerned departments in Birmingham. Also, data from the license plate survey performed on November 7th are being tabulated at the moment. Results of this survey may help make better decisions with regards to better solutions to traffic problems in the area.

It is recommended that all traffic improvement measures in the area be put on hold until "ideal" solutions to the problems are developed by the cities of Troy and Birmingham cooperatively.

Traffic Committee Meeting of 11-20-94 Recommendation No. 4 - No Right Turn 5:00 - 6:00 P.M. at Coolidge and Derby

The Traffic Committee, at their November 20, 194 meeting, considered a request for and recommended the installation (on a 90 day trial basis) of a *No Right Turn* sign at Coolidge and Derby.

We are currently conducting a joint traffic study of this area with the City of Birmingham. We have performed a license plate survey of this area and the results are ready to be reviewed by the communities.

The placing of a *No Right Turn* sign at Derby, at this time, is premature and could aggravate the Birmingham residents and jeopardize harmonious relations between our cities. Southbound traffic on Coolidge, which could not turn westbound on Derby, would probably proceed to Pembroke, Manchester or other Birmingham streets, south of Derby, then turn right and travel through Birmingham streets to get to their destination. This shifting of traffic to Birmingham streets would conflict with our previous agreement to deal with these traffic concerns in total and the spirit of cooperation which currently exists.

Therefore I recommend that no actions on this matter be taken until the joint study is concluded and a mutually acceptable plan of action is agreed upon.

No Right Turn Signs on Derby at Coolidge

At the Traffic Committee meeting of November 20, 1996, the Traffic Committee recommended that City Council approve a prohibition on right turns from Coolidge onto Derby for a 90 day period. We disagree with this recommendation. We believe the installation of a "No Right Turn" sign on Coolidge at Derby would have a chilling effect upon the spirit of cooperation between the City of Troy and the City of Birmingham as we conduct a joint traffic study in the area. When traffic is diverted from Derby to adjacent streets such as Witherbee and Glouchester in Troy and Pembroke and Manchester in Birmingham, we believe that the residents of those streets will be asking their respective City Councils how such a decision could be made without their input. We recommend that changes to traffic patterns in this area be undertaken on an area-wide basis, so that the views of all affected parties may be considered.

The Cities of Troy and Birmingham conducted a license plate survey in this area on November 7, 1996, and the results of this survey are being tabulated. When the tabulation is complete, we will be able to identify how much "cut through" traffic there is in the area. We will also be able to determine where this traffic enters and exits the one-square-mile area bounded by Big Beaver, Coolidge, Maple and Adams. This information would certainly be helpful to the City Councils of both communities in making decisions about changing traffic regulations and traffic patterns in the area. We suggest that these decisions be deferred until this information is available.

You may recall that there was some concern that studies conducted in June of 1996 would not reflect additional traffic loading anticipated from the Somerset North Mall opening and the impact of school traffic. Our initial analysis of traffic data available from October and November 1996 indicate that traffic volumes on Derby, Eton, and Witherbee are the same or slightly lower than they were before Somerset North Mall opened.


