At the Traffic Committee meeting of September 1, 1988, the following recommendations were made for City Council approval:

1. (4) Recommend that no change be made to existing traffic control devices at Montclair and Lovell.
2. (6) Recommend that the fire lanes shown on the attached sketch be established at Mon Jin Lau, 1515 East Maple.
3. (7) Recommend that the fire lanes shown on the attached sketch be established at Merchant of Vino, 4048-4066 Rochester Road.
4. (8) Recommend that the yield signs on Cliffside at Patterson be replaced with stop signs.
5. (10) Recommend that no change be made to existing traffic control devices on Continental at Heritage.
6. (11) Recommend that yield signs on Holly at Barclay be replaced with stop signs.
7. (11) Recommend that no change be made to existing traffic control devices at Barclay and Randall.
8. (12) Recommend that no additional traffic control devices be installed to regulate traffic on Kristin at Coolidge.




