CITY OF TROY

An Ordinance to amend Chapter 90 of the Code of the City of Troy

The City of Troy ordains:

Section 1: Short Title

This Ordinance shall be known and may be cited as the _____amendment to Chapter 90 of the Code of the City of Troy.

Section 2.

Section 18 (1) is hereby amended to read as follows:

(1) The license fees shall be:

Section 3.

Section 19 is hereby amended to read as follows:

19. License Tags and Collars. Upon payment of the license fee the City Clerk shall issue to the owner a license tag of metal or other suitable material, not less than one (1) inch in length or diameter, containing the number of the license, the year of issuance, and words "Licensed, Troy, Michigan" and also bearing the word "Immunized". Every owner shall be required to provide each dog with a collar to which the license tag must be affixed, and shall see that the collar and tag are constantly worn. Absence of the collar and license tag from any dog shall be prima facie evidence that said dog is not licensed, and any person finding such dog on his premises or running at large may seize and deliver such dog to the dog pound.

No person shall remove any license tag from any dog without the consent of the person owning or harboring said dog, and no tag shall be used on the collar or harness of any dog other than the dog for which the tag was issued. In case a dog tag is lost or destroyed, a duplicate will be issued by the City Clerk upon presentation of a receipt showing the payment of the license fee for the current year, and the payment of a \$2.00 fee for such duplicate. No refund shall be made on any dog license fee.

Dog License Fees

It is requested that we increase our fee for a duplicate license from \$1.00 to \$2.00; and that we increase the dog license fees for unsexed dogs from \$2.50 to \$5.00 and for male and female dogs from \$3.00 to \$7.50.

A comparison of 1984 dog license fees is attached. This change would make our fee the same as Birmingham and Oakland County; our penalty rate would remain at 50%.

The attached ordinance would increase the fees, and would change the last sentence of Section 19 from "No refund shall be made on any dog license fee because of the death of the dog or the owner's leaving the City before expiration of the license period." to "No refund shall be made on any dog license fee."
