

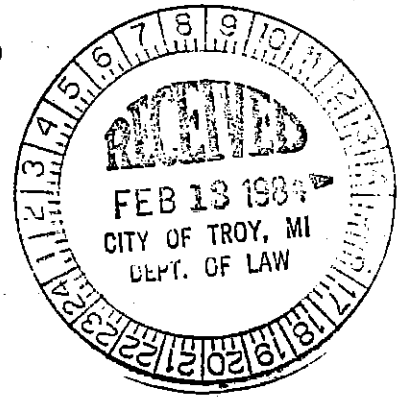

AN ORDINANCE TO AMEND
CHAPTER 90 OF THE CODE
OF THE CITY OF TROY

THE CITY OF TROY ORDAINS:

Section 1: Short Title

This Ordinance shall be known and may be cited as the _____
Amendment to Chapter 90 of the Code of the City of Troy.

Section 2:

Chapter 90 is hereby amended to include domestic cats within
licensing scheme:

1. Chapter 90 (1)(8) should be amended to strike the
words "household cats".

(8) Animal - Any living creature, domestic or wild,
excluding for the purpose of licensing, small caged
household pets such as, but not limited to, parakeets
and parrots, fish, household-cats, insects, common
store sold rodents and reptiles, or similar animals
of a passive, undangerous nature.

2. Chapter 90 (16), (17), (18), and (19) should be
amended as follows:

DOGS; CATS

16. Dog Licenses Required; Cat Licenses Required. It
shall be unlawful for any person to own, keep, or harbor
any dog or cat six (6) months of age or over in the City
of Troy, unless said dog or cat is licensed as hereinafter
provided; or to own, harbor, or keep any dog or cat six
(6) months of age or over that does not at all times wear
a collar or harness with a metal tag attached as herein-
after provided.

17. License Applications. Individual dog and cat licenses
shall be issued by the City Clerk upon application and
payment of the license fees provided in this Chapter. The
application for a dog or cat license shall be accompanied
by a certificate signed by a veterinarian stating that said
said dog or cat has been properly immunized against rabies.
It shall be the duty of any person owning or harboring a dog
or cat on or before the 1st day of March of each year, or
on or before the date any such dog or cat becomes six (6)
months of age, or within thirty (30) days after such person
becomes a resident of the City of Troy, or within thirty (30)
days after he becomes the owner of a dog or cat six (6)
months of age or more, to apply for a license; provided,
that no person shall keep more than three (3) dogs;

further provided, that any person who runs a dog kennel that is properly licensed need not apply for individual dog licenses under this Chapter. All dog or cat licenses hereafter issued shall expire on the first day of March in the year following their issuance.

18. License Fees.

(1) The license fees shall be:

Each unsexed dog; <u>unsexed cat</u>	\$2.50
Each female dog; <u>each female cat</u>	3.00
Each male dog; <u>each male cat</u>	3.00
Each leader dog for a blind person	-0-

(2) In the case of a dog which has been duly licensed in another county, city or village in the State of Michigan, or by lawful authority of any state in the United States of America, if application for license is made by the owner or person harboring such a dog within thirty (30) days prior to the expiration of his foreign license, the license fee shall be one-half of the regular fee.

(3) When an application for license is made after March 1st, or more than thirty (30) days after a dog or cat is six (6) months of age, or after the dog or cat has been acquired, or its owner has moved into the City, an additional charge shall be made by way of penalty amounting to one-half of the license fee; provided, however, in the case of anyone moving into the City after March 1st, or owning or acquiring a dog or cat becoming six(6) months of age after March 1st, or acquiring a dog or cat after March 1st, and furnishing satisfactory proof to the Clerk of such facts, the license fee shall be the same as for licenses issued prior to March 1st.

(4) In the case of any license issued after November 1st, provided that owner proves to the satisfaction of the City Clerk that the dog or cat was not acquired by the owner prior to November 1st, or did not become six (6) months of age prior to November 1st, or that the owner was not a resident of the City and owner of the dog or cat prior to November 1st, the license fee shall be one-half of the regular fee.

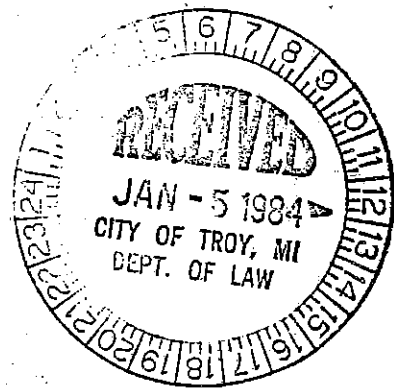
19. License Tags and Collars. Upon payment of the license fee the City Clerk shall issue to the owner a license tag of metal or other suitable material, not less than one (1) inch in length or diameter, containing the number of the license, the year of issuance, and words "Licensed, Troy, Michigan"

and also bearing the word "Immunized". Every owner shall be required to provide each dog or cat with a collar to which the license tag must be affixed, and shall see that the collar and tag are constantly worn. Absence of the collar and license tag from any dog or cat shall be prima facie evidence that said dog or cat is not licensed, and any person finding such a dog or cat on his premises or running at large may seize and deliver such dog or cat to the dog pound.

No person shall remove any license tag from any dog or cat without the consent of the person owning or harboring said dog or cat, and no tag shall be used on the collar or harness of any dog or cat other than the dog or cat for which the tag was issued. In case a dog or cat tag is lost or destroyed, a duplicate will be issued by the City Clerk upon presentation of a receipt showing the payment of the license fee for the current year, and the payment of a \$1.00 fee for such duplicate. No refund shall be made on any dog or cat license fee because of the death of the dog or cat or the owner's leaving the City before expiration of the license period.

AN ORDINANCE TO AMEND
CHAPTER 90 OF THE CODE
OF THE CITY OF TROY

THE CITY OF TROY ORDAINS:

Section 1: Short Title

This Ordinance shall be known and may be cited as the _____
Amendment to Chapter 90 of the Code of the City of Troy.

Section 2:

Chapter 90 is hereby amended to include domestic cats within
licensing scheme:

1. Chapter 90 (1)(8) should be amended to strike the
words "household cats".

(8) ~~Animal~~ - Any living creature, domestic or wild,
excluding for the purpose of licensing, small caged
household pets such as, but not limited to, parakeets
and parrots, fish, ~~household-cats~~, insects, common
store sold rodents and reptiles, or similar animals
of a passive, undangerous nature.

2. Chapter 90 (16), (17), (18), and (19) should be
amended as follows:

DOGS; CATS

16. Dog Licenses Required; Cat Licenses Required. It
shall be unlawful for any person to own, keep, or harbor
any dog or cat six (6) months of age or over in the City
of Troy, unless said dog or cat is licensed as hereinafter
provided; or to own, harbor, or keep any dog or cat six
(6) months of age or over that does not at all times wear
a collar or harness with a metal tag attached as herein-
after provided.

17. License Applications. Individual dog and cat licenses
shall be issued by the City Clerk upon application and
payment of the license fees provided in this Chapter. The
application for a dog or cat license shall be accompanied
by a certificate signed by a veterinarian stating that said
said dog or cat has been properly immunized against rabies.
It shall be the duty of any person owning or harboring a dog
or cat on or before the 1st day of March of each year, or
on or before the date any such dog or cat becomes six (6)
months of age, or within thirty (30) days after such person
becomes a resident of the City of Troy, or within thirty (30)
days after he becomes the owner of a dog or cat six (6)
months of age or more, to apply for a license; provided,
that no person shall keep more than three (3) dogs;

further provided, that any person who runs a dog kennel that is properly licensed need not apply for individual dog licenses under this Chapter. All dog or cat licenses hereafter issued shall expire on the first day of March in the year following their issuance.

18. License Fees.

(1) The license fees shall be:

Each unsexed dog; <u>unsexed cat</u>	\$2.50
Each female dog; <u>each female cat</u>	3.00
Each male dog; <u>each male cat</u>	3.00
Each leader dog for a blind person	-0-

(2) In the case of a dog which has been duly licensed in another county, city or village in the State of Michigan, or by lawful authority of any state in the United States of America, if application for license is made by the owner or person harboring such a dog within thirty (30) days prior to the expiration of his foreign license, the license fee shall be one-half of the regular fee.

(3) When an application for license is made after March 1st, or more than thirty (30) days after a dog or cat is six (6) months of age, or after the dog or cat has been acquired, or its owner has moved into the City, an additional charge shall be made by way of penalty amounting to one-half of the license fee; provided, however, in the case of anyone moving into the City after March 1st, or owning or acquiring a dog or cat becoming six (6) months of age after March 1st, or acquiring a dog or cat after March 1st, and furnishing satisfactory proof to the Clerk of such facts, the license fee shall be the same as for licenses issued prior to March 1st.

(4) In the case of any license issued after November 1st, provided that owner proves to the satisfaction of the City Clerk that the dog or cat was not acquired by the owner prior to November 1st, or did not become six (6) months of age prior to November 1st, or that the owner was not a resident of the City and owner of the dog or cat prior to November 1st, the license fee shall be one-half of the regular fee.

19. License Tags and Collars. Upon payment of the license fee the City Clerk shall issue to the owner a license tag of metal or other suitable material, not less than one (1) inch in length or diameter, containing the number of the license, the year of issuance, and words "Licensed, Troy, Michigan"

and also bearing the word "Immunized". Every owner shall be required to provide each dog or cat with a collar to which the license tag must be affixed, and shall see that the collar and tag are constantly worn. Absence of the collar and license tag from any dog or cat shall be prima facie evidence that said dog or cat is not licensed, and any person finding such a dog or cat on his premises or running at large may seize and deliver such dog or cat to the dog pound.

No person shall remove any license tag from any dog or cat without the consent of the person owning or harboring said dog or cat, and no tag shall be used on the collar or harness of any dog or cat other than the dog or cat for which the tag was issued. In case a dog or cat tag is lost or destroyed, a duplicate will be issued by the City Clerk upon presentation of a receipt showing the payment of the license fee for the current year, and the payment of a \$1.00 fee for such duplicate. No refund shall be made on any dog or cat license fee because of the death of the dog or cat or the owner's leaving the City before expiration of the license period.
