Graystone Consulting Group Presentation

- **Market Review – Bob Alati / Brian Brice**
 - Bob discussed the long-term and short-term trends in the stock market highlighting that the long-term trend is still upward.
 - He also discussed chart patterns such as technical formations and continuation patterns developed over the markets.
 - He concluded that we are still in a bull market and there is still no recession.
 - Brian presented the Market Update slides discussing Asset Class Index Performance and Asset Class Returns.
- **Investment Review – Amy Cole**
 - Amy discussed Total Fund Performance noting the YTD Net Returns Net of Fees for the combined accounts as of March 31st, 2019 at 10.76%.
 - Morgan Stanley Portfolio Performance YTD Net Returns Net of Fees as of April 30th, 2019 was 12.15%.
 - She also discussed Total Fund Asset Allocation, Manager Asset Allocation, Manager Performance, and Investment Manager Analysis.
 - She did not have any rebalancing recommendations at this time.

UBS Financial Presentation

- **Market Review – Rebecca Sorensen**
 - Rebecca gave a market update discussing the factors that led to the increase in global assets since the end of last year.
 - She highlighted that we maintain an overweight to equities versus fixed income and also discussed bond yields in the market.
 - They do not anticipate a recession right now.
- **Investment Review – Darin McBride**
 - The performance as of April 30th, 2019 YTD Net Rate of Return Net of Fees was as follows: Combined 14.90%; ERS 13.74%; NAIC 19.27%.




