- Reimbursement to City for pension benefits paid on the System's behalf in the amount of \$6,800,000.
 - The ERS Board directs the Systems Investment Consultants of Graystone to liquidate \$400,000 from Vanguard Total Market. Liquidate \$1,000,000 from Cambiar, and liquidate \$2,000,000 from JP Morgan Strategic Income and to transfer the funds totaling \$3,400,000 from the Troy Employee Retirement System to the City of Troy a partial reimbursement for benefits paid by the City on behalf of the ERS System.
 - The ERS Board directs the Systems Investment Consultants of UBS to Sell all positions in Abbvie for an estimated amount of \$210,000, Sell a partial position in Starbucks to generate \$60,000, Sell all positions in Berkshire Hathaway for an estimated \$200,000, Sell all positions in Lennox for an estimated \$260,000 and all positions in Fortive for an estimated \$185,000. These proceeds along with available cash will be distributed to the City of Troy in the amount of \$3,400,000 as partial reimbursement to the City for benefits paid on behalf of the Troy Retirement System.
