ANIMAL CONTROL APPEAL BOARD

The Animal Control Appeal Board Appeals is a group of five of your neighbors or peers appointed by City Council to pass judgment on requests for appeals, interpretations, and other matters that are brought before them.

PROCEDURE

The Board will hear the items in the order that they appear on the agenda. When an item is called, the Chair will verify that the petitioner is present. The petitioner will then be given an opportunity to address the Board to explain the justification for the action requested.

After the petitioner makes their presentation, and answers any questions that the Board may have, the Chair will open the meeting to public comment. Any person wishing to speak on the request should raise their hand to be when recognized by the Chair. The speaker should identify themselves with name and address, indicate their relationship to the property in question (i.e. next door neighbor, live behind the property, etc.) and state whether they are in favor of or against the request and give reasons for their opinion. Comments must be directed through the Chair. Comments should be kept as brief as possible and closely pertain to the matter under consideration. Only one person will be recognized by the Chair to speak at one time.

After interested members of the public have spoken, the Chair will close the public comment. Once the public comment is closed, no other public comment will be taken unless in response to a specific question by a member of the Board. The Board may allow the petitioner to address or rebut public comments.

The Board will then deliberate and make a motion to approve, deny, or postpone the request. In order for the request to pass a minimum of three votes for approval are needed. The decision of the Board is final.

Chair Saeger asked the applicant to address the Board. Ms. Blessing-Bielecki indicated that she wanted to use the chickens as a teaching tool for her young daughter. The Board had no questions for the applicant.

Chair Saeger opened the public hearing. No members of the public spoke. Chair Saeger closed the public hearing. Mr. Evans summarized an e-mail sent by an area resident in favor of the request. In response to Mr. Floch’s question, Mr. Evans advised the e-mail sender’s property is .83 acres in area.

Board members asked the applicant to discuss their experience raising chickens, why she needed 6 chickens, the presence of fencing, and the breed of chickens.

Citing no support from adjacent neighbors and his belief that the property size is considerably less than .75 acres, Mr. Carolan said he was not comfortable approving the request. Mr. Petrulis and Mr. Floch agreed that the lot size was a concern for disapproving the request.

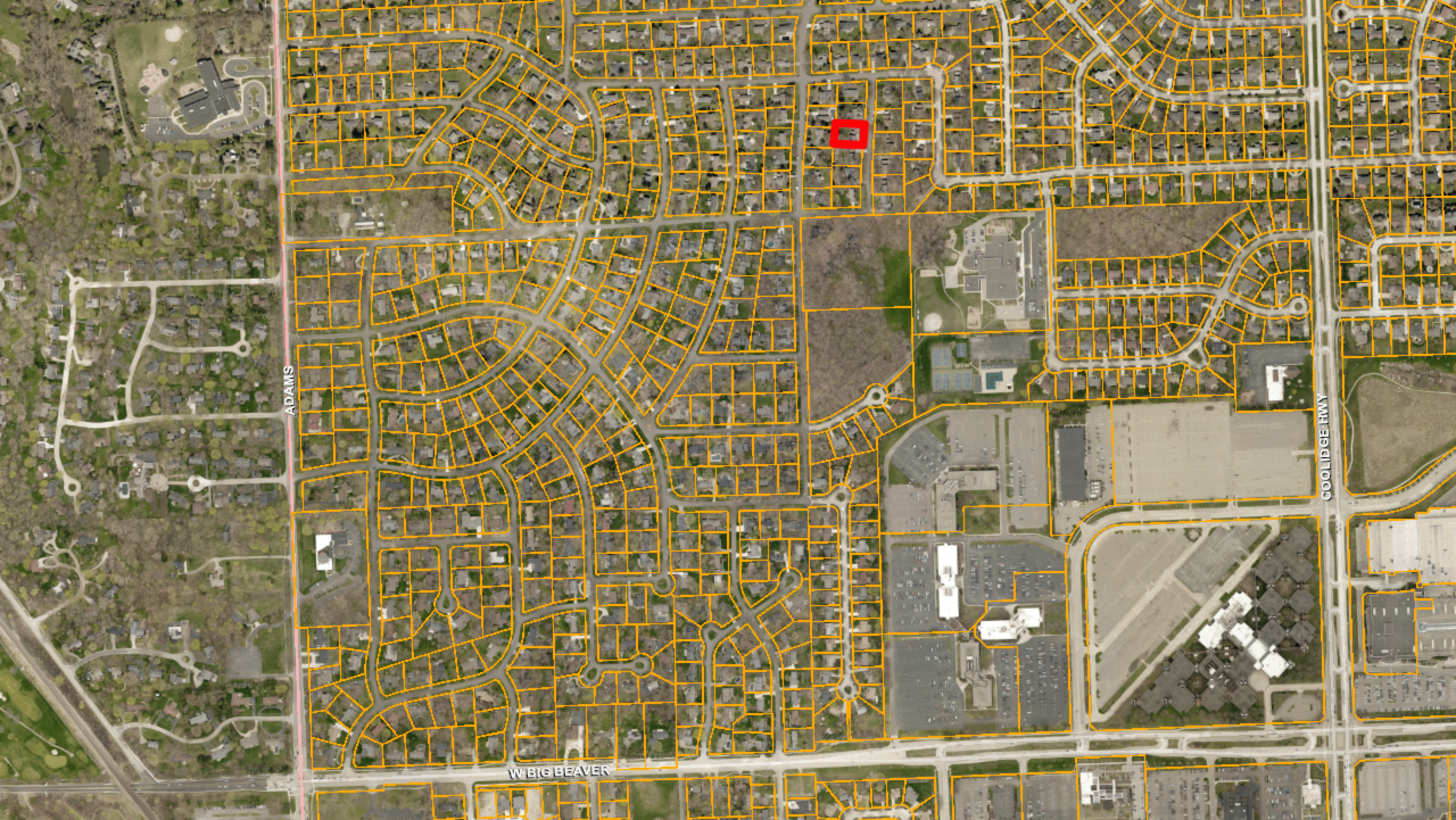

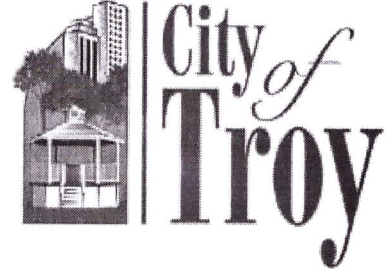

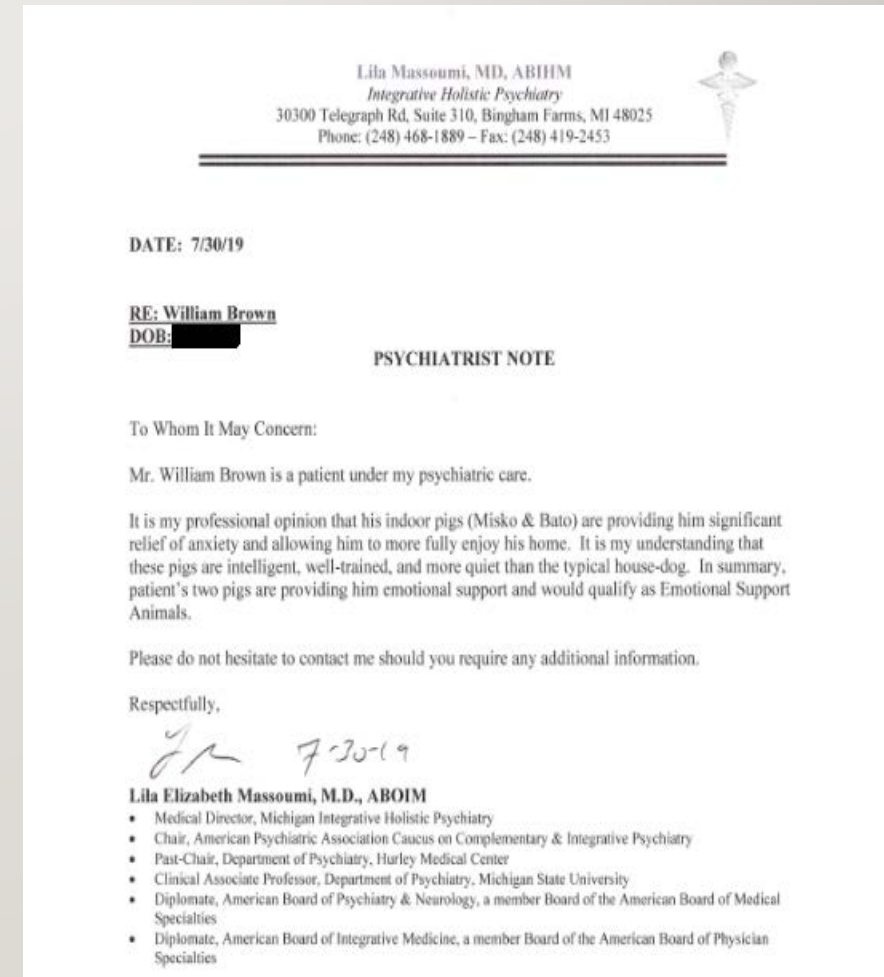


NARRATIVE & PURPOSE OF REQUEST

- Our goal is to save our mini pigs from being removed from the city limits based on a lot size requirement of $\frac{3}{4}$ of an acre. Nina & I moved to Troy in June of 2018. We love this city and we visited several homes prior to coming to our decision to purchase in Troy. We enjoy the proximity to restaurants, shopping, and entertainment, while still being able to maintain some of the simpler joys of homeownership. Our neighborhood is quiet, peaceful, and welcoming. We have a wonderful relationship with all of our neighbors up and down Eastbourne and all have been more than happy to meet Misko & Bato (Our Pet Mini Pigs) and support us in our quest for a variance to the acreage requirement to keep pets classified as “livestock”. Our little guys differ from livestock in several ways. First, they make us no money... in fact they cost us quite a bit of money. They are not raised for labor, profit, or as food (slaughter). Their feed is not subsidized by any state or local government... their feed is taxed just like dog food or cat food, separating them from livestock (livestock feed is not taxed in any way). They are fundamentally different from livestock in more ways than just state regulations pertaining to feed taxes. Pigs are scientifically proven to be as intelligent and cognizant as a 4 year old human being. They are also considered to be the 4th smartest animal on Earth. Pigs are one of the most misunderstood and mistreated animals in the animal kingdom. Common misconceptions include but are not limited to the following; Pigs are dirty. Pigs stink. Pigs are lazy. The stereotypes surrounding this wonderful species run amuck in a society that has historically mistreated one of the most intelligent, emotional, trainable, developmental, and communicable animals on our planet. Misko & Bato are loving house pets whose tails wag when Nina and I return from work, demonstrating their capability to show and feel emotion, much like your cats and dogs. They differ from Hogs and Swine in so many ways we'd need an entire day for me to explain fully. For starters, they weigh only 40 to 50 pounds each... much smaller than my previous pet, Walter the Sheepdog who weighed in at well over 110 lbs. and stood almost 3.5' tall on all fours. In the coming slides, we will show proper housing and care is provided for our wonderful house pets at all times. They are never neglected or mistreated and arrangements have been made to care for them should we need to go out of town for work or play. Our neighbors have pitched in to assist in taking care of them in the past and we value their help as much as any pet parent can. Neighbors on Eastbourne Drive stop by regularly and ask to see our little guys because their pleasant oinking and calm demeanor bring joy to all that take the time to know and understand both Misko & Bato. Documentation, micro-chips, neutering and medical records, psychiatric prescriptions for emotional support animals (ESA's), and proper vaccinations are all provided in this presentation to reaffirm the Board's confidence in our commitment to properly care for Misko & Bato and the importance we place on the protection of our fellow Troy residents. We love this city and we respect the rights of our neighbors to have a safe and peaceful neighborhood. All we ask is that we are allowed to keep our special pets who have become an integral part of our family unit.

OUTDOOR PEN

- Purpose: Pigs need to have a place to be pigs... no matter how small they are, instinctually, they will always be pigs. They need to have an area designed to allow them the freedom to root and exercise. Fresh water source mounted to tree.
- Pen Dimensions: 10' 7" Wide X 17' 4" Long X 4' High – Equipped with Latch and Lock to Prevent Escape
- Post & Rail Design with Poultry Net Interior



GARAGE PEN

- Purpose: Misko & Bato need shelter from the elements but also require fresh air and straw to keep their body temperatures regulated. Straw provides them warmth in the Winter and helps to keep them cool in the Summer (A Pig's Natural Body Temperature is 102 Degrees Fahrenheit). Pigs cannot sweat so regulating body temperature is important. They are provided a fan at all times in the garage during the Spring, Summer, & Fall seasons. Because they cannot sweat, Pigs also never stink.
- Pen Dimensions: 7' 10" Wide X 5' 3" Long X 4' High – Equipped with Latch & Lock to prevent escape & monitored 24-7 by SimpliSafe camera with two way audio so we can speak to them and calm them down if they are scared or upset in any way.
- Post & Rail Design w/built in litter box and pet bed for comfort – Concrete floor provides a natural way to keep hooves at an acceptable length (Abrasive)



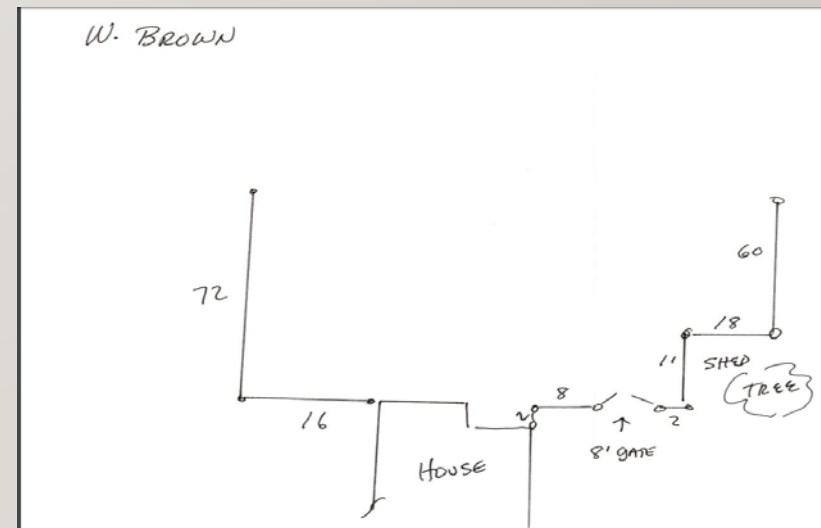
KITCHEN DINETTE PEN

- Purpose: During the cold Winter months an indoor, heated pen is required. This is also where Misko & Bato spend the majority of their time, in our house as our house pets. The dinette is better repurposed for our situation as a mini pig pen where we can keep an eye on our little guys and keep them warm and cool as dictated by the seasons.
- Pen Dimensions: 6' Wide X 6'3" Long X 3' High – Equipped with Latch & Lock to prevent escape & monitored by SimpliSafe camera with two way audio so we can speak to them if needed.
- Post & Rail Design w/mobile litter box and pet bed for comfort; Porcelain Tile Floor with RedGuard backing to make the area waterproof should they spill their water or have an accident during the day



BACKYARD

- Purpose: Fence – Should our pigs escape their outdoor pen, a permanent, professionally installed fence now exists on the property to prevent their escape from the backyard and to prevent our pets from running at large.
- Dimensions: .40 Acre Lot
- Black Aluminum Design w/8' Gate at Driveway equipped with Latch & Lock to prevent escape
- Cost: **\$8,000** w/Installation – This fencing was not present when the house was purchased... but we matched the design with our neighbors' existing fence to avoid dissatisfaction with the addition.

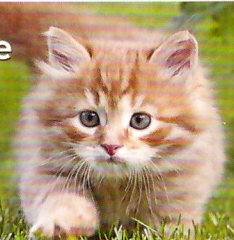
