A. Planning and Development Update - (Presented by Brent Savidant, Planning Director and Glenn Lapin, Economic Development Specialist)

Planning Director Savidant spoke about 888 building development progress including 300 unit apartment complex and Huntington Bank property. Economic Development Specialist Lapin spoke about Cooper's Hawk Winery, the demolition of the Kruse Muer restaurant and an overview of Opportunity Zones and how these programs were established and operate.

B. Approval of 2019-20 Budget - (Presented by Mark F. Miller, City Manager and Tom Darling, Director of Financial Services)

Executive Director Miller reviewed the 2019-20 budget noting total revenues of approximately \$1.8 million and total expenditures of approximately \$1.3 million indicating a budgeted increase in Fund Balance of approximately \$547 thousand. He also indicated that the 2019-20 budget will be the first year of anticipated QDI reimbursement expenditures budgeted at approximately \$15 thousand in addition to a new budgeted line item for District Promotion budgeted at \$25 thousand. Total debt expenditures are budgeted at approximately \$924 thousand and it is anticipated that future tax capture will generate the revenues to service future debt service requirements.
