Robert Bednas of Kirco Realty and Development and Wendell Kaufman, the tenant were present. Mr. Bednas stated that the elevator lobby and tenant lobby adjacent to this space are open areas. They are requesting that this area be locked and that entry can only be gained through the tenants own access card system. They feel that this type of system will provide them with the security needed by the tenant and provide safety to their employees who work after 5:00 p.m. They will provide a telephone in the lobby area that is tied into the fire management system should someone gain access to the floor and become trapped.
