ORDER OF CITY OF TROY ACT 78 CIVIL SERVICE COMMISSION

This matter having come on to be heard before this Board upon the appeal of DANIEL M. BOWE, a probationary police officer, from the decision of the appointing authority to deny him permanent tenure status, and upon remand by the Oakland County Circuit Court back to this Commission of the matter following the Respondent's appeal of this Board's previous decision;

In support of this Order the Commission notes for the record that:

- 1. The discharge authority Frank Gerstenecker, City Manager for the City of Troy, has indicated to this Commission that after he took action to deny officer Bowe permanent appointment certain information or facts were presented to him that was not available to him at the time of his initial review and action to deny appointment to officer Bowe.
- 2. The parties through their attorneys have pursued this matter in the Oakland County Circuit Court by way of an appeal filed by Daniel Bowe. The parties are now desirous of avoiding any extended litigation over this matter and the accompanying legal cost and fees of further appeals. The parties have also noted to this Commission that besides the legal appeals being pursued by officer Bowe, he is

- C. That the personnel records of DANIEL M. BOWE be purged of any reference to the incidents which gave rise to his discharge or to the discharge itself.
