- Election Results
 - Peter Dungjen was elected to serve as a member of the ERS and RHC Boards for a term ending December 31, 2023.
 - Administrator Maleszyk congratulated and welcomed Trustee Dungjen to the Board.
- MBC Investment Consulting Mark Woolhiser / Joe Warsecke
 - MBC Investment Consulting was hired last fall to help us with the Defined Contribution plan to review cost structures and the best investment selections for the participants.
 - They discussed the fee summary and what is being paid to ICMA-RC and what the fees and cost savings were after re-bidding the plan to ICMA-RC in comparison to 2 other competitive proposals.
 - MBC also discussed Revenue Sharing and presented the Total Cost Analysis.
 - They concluded that the cost was able to be driven down from \$982,914 to

\$443,943 and recommend that a 3-year contract be signed with ICMA-RC to lock in this price.

- MBC will continue to help with the relationship with ICMA-RC, continue to provide guidance and monitor the funds every quarter and their contractual relationship with the City will continue.
- Trustee Miller will send out an email in the coming days notifying participants of the changes they can expect to see on their portfolios and more information regarding the educational meetings that they can attend.
