 - Mark introduced Tyler Neenan, an investment advisor from BlackRock.
 - Tyler briefly discussed market recovery noting that in spite of tight labor markets and inflation there has been a strong recovery in the market.
 - He presented the BlackRock LifePath Target Date fund Quarter 2 reports noting that LifePath has delivered strong absolute returns overtime and the outcomes have aligned with the glidepath objectives.
 - Mark presented the Fiduciary Investment Review Reports for the 457/401A plans for quarter ending June 30th, 2021 discussing the Total Plan Asset Allocations and their scorecard.
 - He also presented the Plan Allocation by Investment Type for the 401A/457B plans concluding that they would like to watch the Small Cap Value funds.
 - MBC also presented the Investment Review reports for the Retirees Health System Portfolio.

MissionSquare Retirement Investment Review – Ray Fortin

- Ray presented the Defined Contribution Plans Quarter 2 reports noting that there are 26% of participant assets in Asset Allocation Funds.
- They recommended that further Employee Investment Education be conducted with a focus on the importance of Asset Allocation and presented the next line up of on-site education meetings scheduled for September and November.
- Trustee Gordon inquired if an education session could be recorded for police staff who work the night shifts and can view at a later time.
- Trustee Bovensiep noted that as an organization it would be best to re-think how to motivate and encourage employees into participating in the educational meetings.
