PROCEDURE

The Board will hear the items in the order that they appear on the agenda. When an item is called, the Chair will verify that the petitioner is present. Then the City Administration will summarize the facts of the case. The petitioner will then be given an opportunity to address the Board to explain the justification for the action requested.

After the petitioner makes their presentation, and answers any questions that the Board may have, the Chair will open the Public Hearing. Administration will present public comments to the Board.

At the conclusion of public comments, the Chair will close public comment. Once the public comment is closed, no other public comment will be taken unless in response to a specific question by a member of the Board. The Board may allow the petitioner to address or rebut public comments.

The Board will then deliberate and make a motion to approve, deny, or postpone the request. In order for the request to pass a minimum of three votes are needed. The decision of the Board is final.

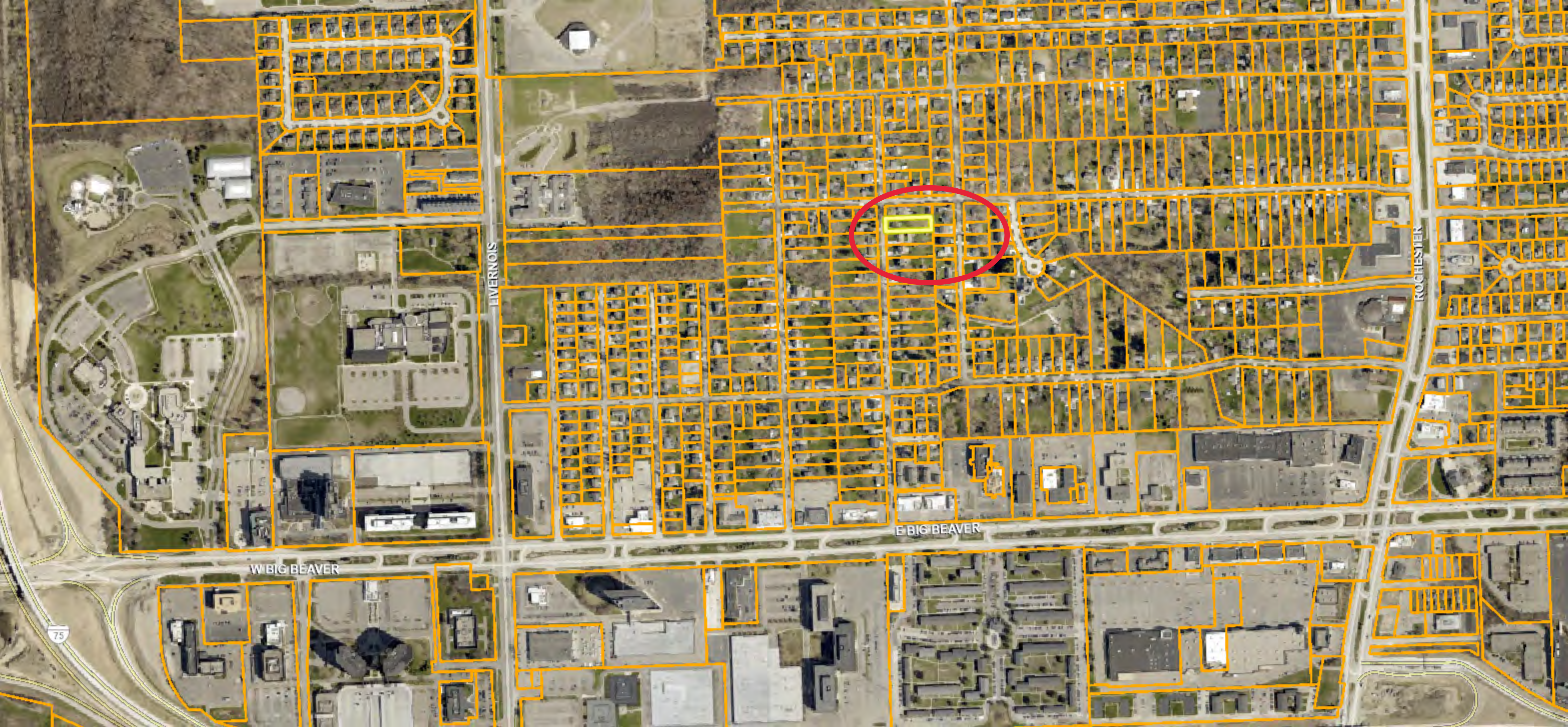

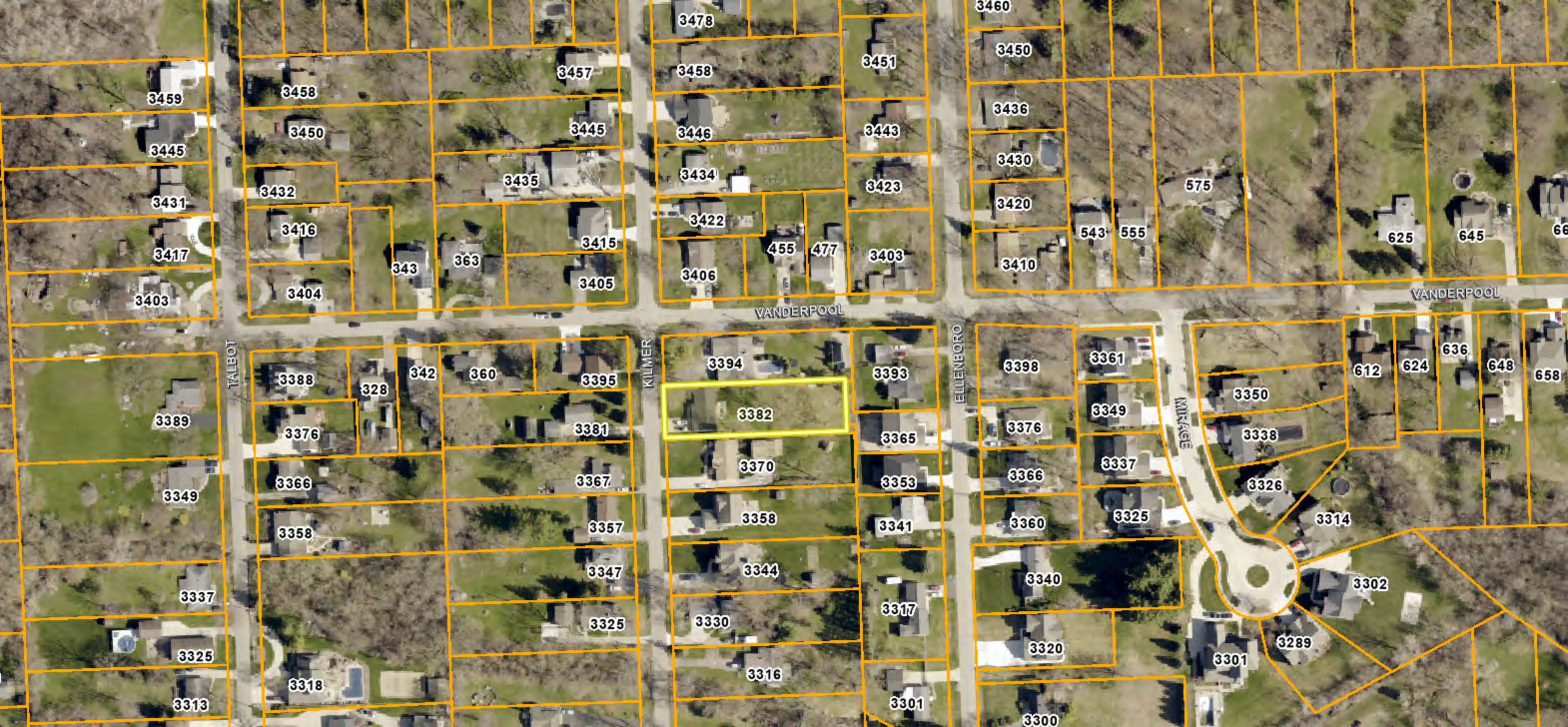

Dear Animal Control Appeals Board Members,

We are Ramanathan Thangapandi and Kalaiarasy Sivasundarapandian, owner and residents of 3382 Kilmer Dr, Troy, MI 48083. Our house is in a parcel that is little less than 0.5-acres in size and it has a fenced spacious backyard. Since our property is less than $\frac{3}{4}$ of an acre needed in Troy to keep chickens, we are writing to seek a waiver so that we can keep small number of egg-laying chickens of no more than 8 birds max on our property.

Below are some of the benefits and reason for this waiver request

- 1) To feed healthy natural fresh eggs to my children and family which are free from any chemicals/hormones/antibiotics
- 2) Eating the natural fresh egg helps me to keep my Inflammatory Bowel Disease (IBD): Ulcerative Colitis under control – Refer attached Annexure B for Egg and its benefit for Ulcerative Colitis disease
- 3) The egg we get from retail stores is triggering the gut inflammation and leading to severe flare-up condition which I didn't experience with fresh eggs. I consume 4 to 6 eggs everyday which helps to manage my disease.
- 4) The chicken in the backyard keeping me active and move around to take care of them. This helps me to manage another linked auto immune disease - Ankylosing Spondylitis.
- 5) The chicken in the backyard gives happiness to our family and my children as a good hobby
- 6) The kitchen vegetables scrap and grass from lawn mowing is consumed by Chickens and not going to landfill. The Chicken waste/manure is used as fertilizer for garden.

We have built a chicken coop of size 10ft by 5ft which is spacious to accommodate 8 chickens. Also, we built outdoor chicken run area of size 10ft by 15ft which is covered with 7feet tall steel fence to protect from any ground predators. The run area's top side is enclosed with chicken wire to protect from any sky predators. We installed automatic chicken coop door which opens to the enclosed outdoor run area. We installed chicken food feeder and chicken water system with deicer to provide food and clean water to chickens all the time. The chicken coop inside got wooden bars for chicken to sleep in the night and the floor is filled with dry straws and maintained periodically. We have chosen winter hardy chicken breeds (Rhode Island Red, Easter Egger and ISA Brown) which does not require heated coop if the coop is wind proof.

I have taken following measures to avoid disturbance to neighbors

- 1) I grow only hens and will not grow rooster to avoid the loud sound from rooster. The breeds we chosen are quite and does not make any loud noise
- 2) The Chickens are not detrimental to the neighborhood as they are confined in one area of the backyard with fencing.
- 3) Chickens will not be released to the backyard from its housing

Also, herewith we like to express our willingness to make any changes to address any concerns from neighbors or city.



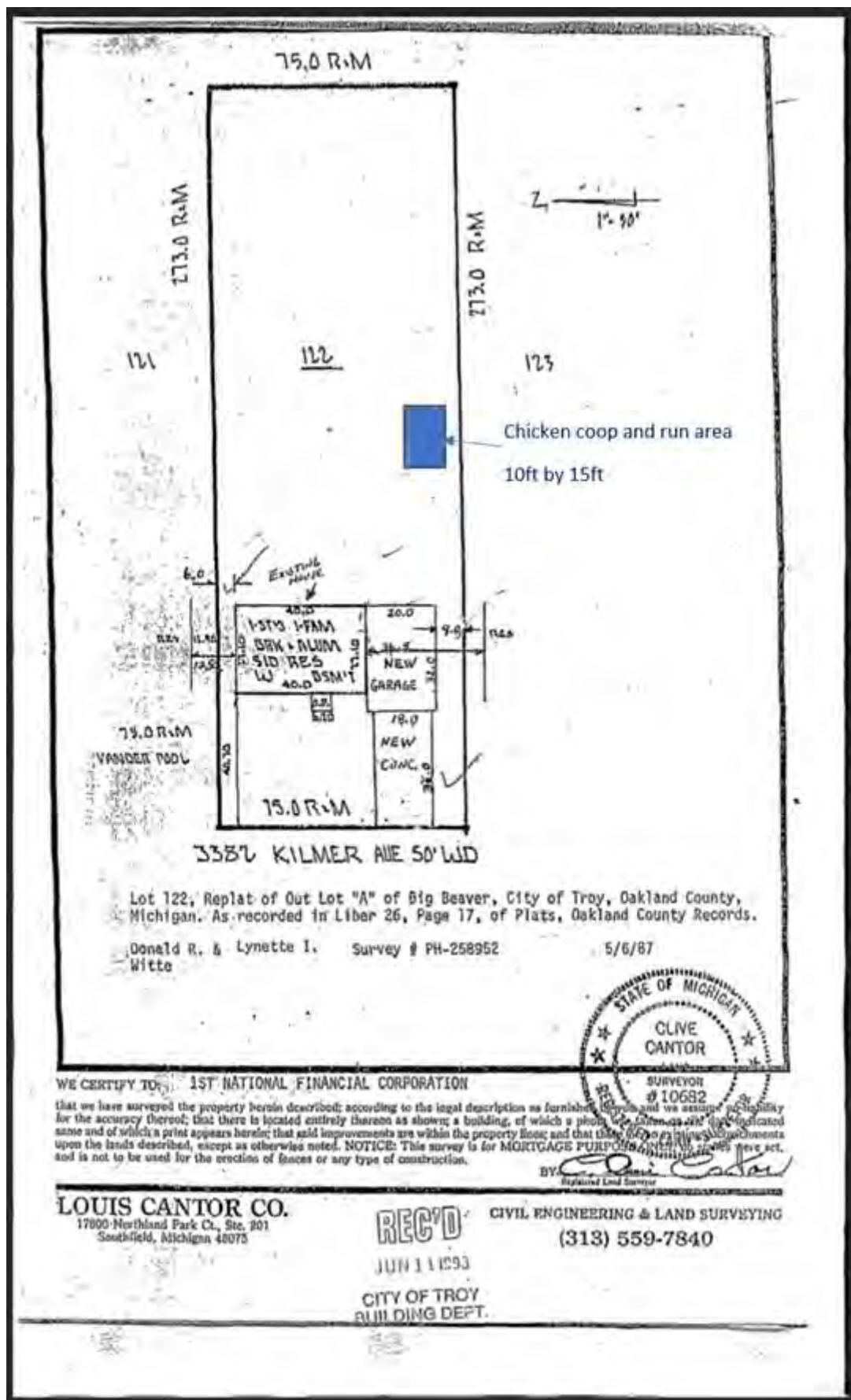

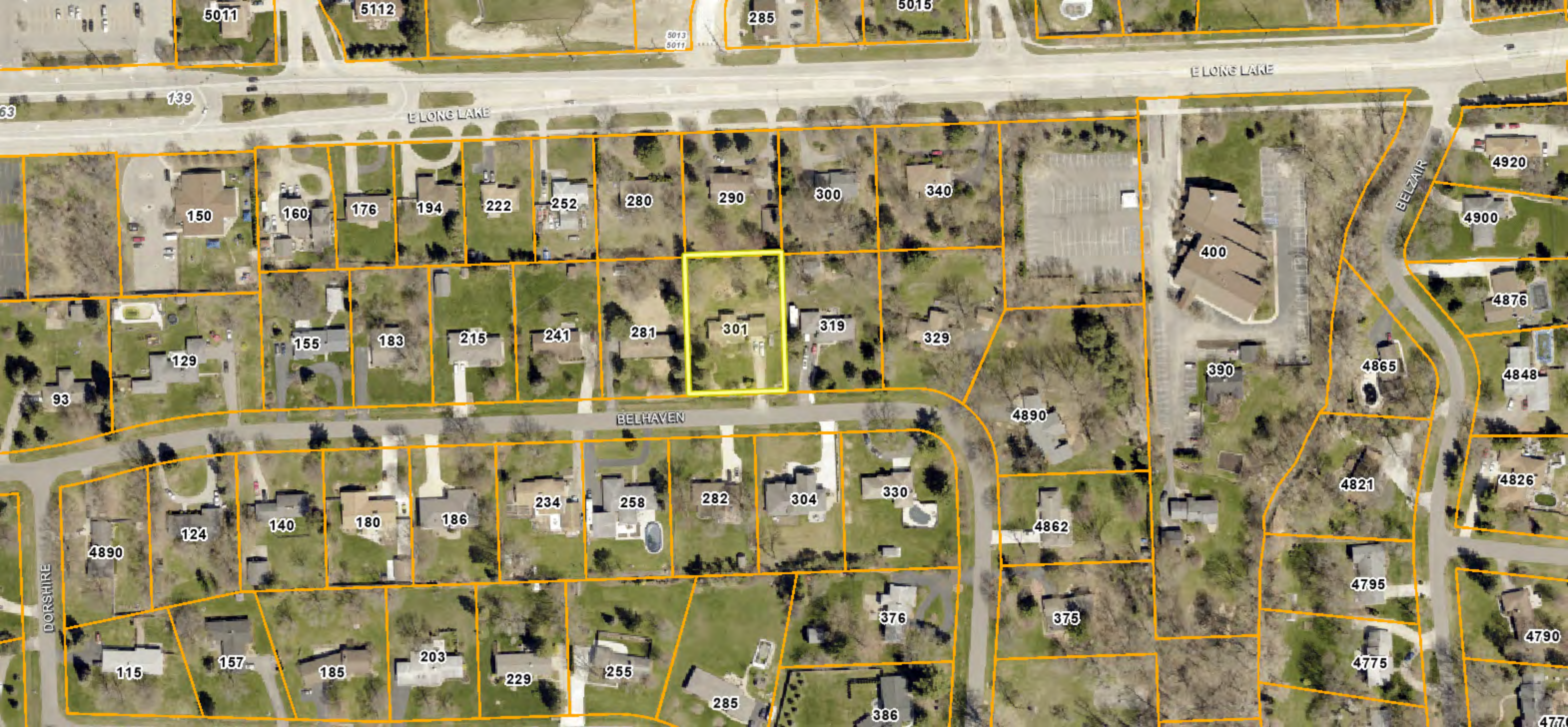

I am writing this letter to go alongside my application to request for a waiver for permission to purchase and raise chickens on my property. I know that the minimum requirement for chickens in Troy is $\frac{3}{4}$ of an acre and my property is just under that amount. I think that the chickens would be very beneficial to my family. I am looking at getting 7 chickens to use for eggs. In my research I have found out that there are quite a lot of different breeds. Since I am looking at getting chickens for eggs, I have found some breeds that not only lay well but also are very docile and not as loud. Although there are no chickens that are 100% quiet all day there are definitely a few breeds that are known to be on the quieter side and such a joy to have around that some people even like to have them as pets! Aside from using the chickens for eggs I have also put a lot of research into using the waste from the chickens as fertilizer for my garden so nothing is wasted. 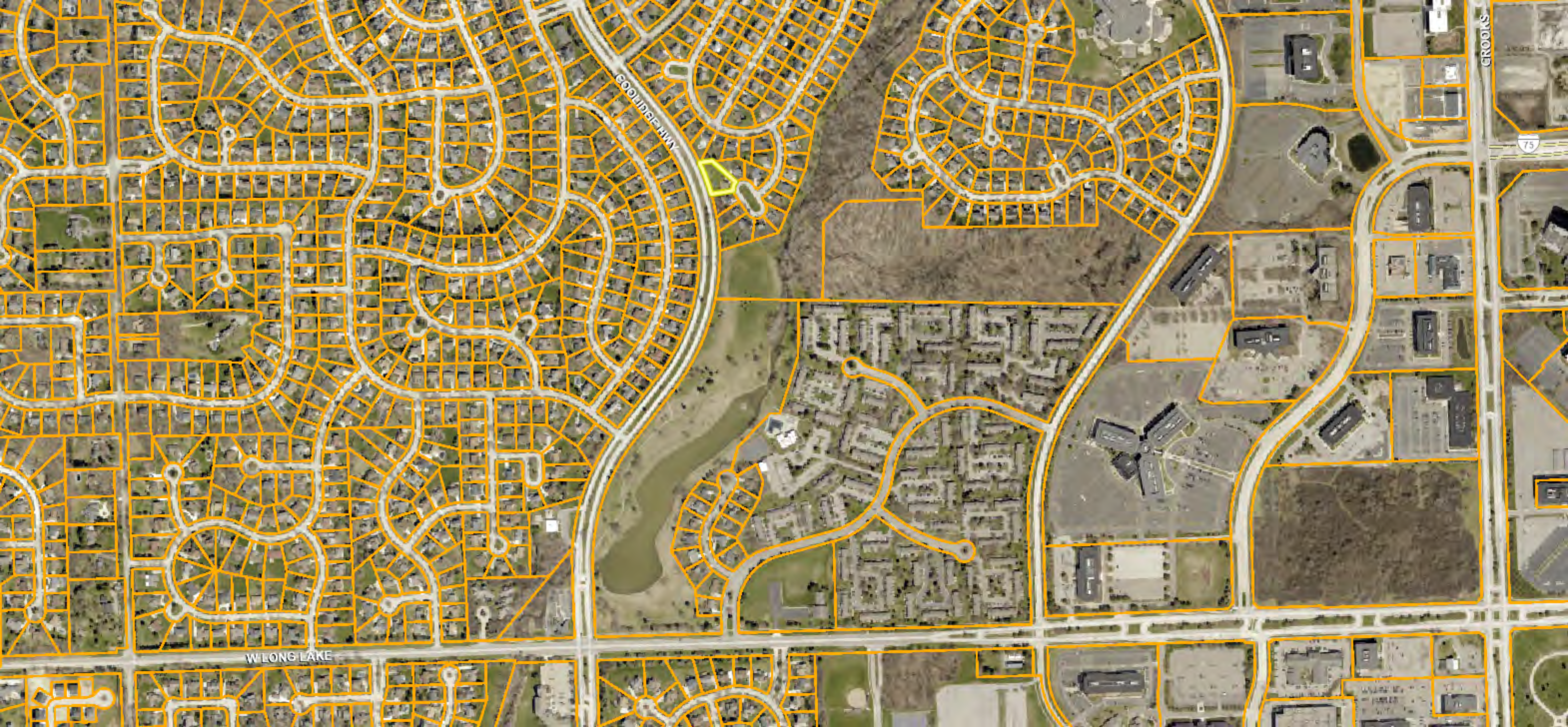

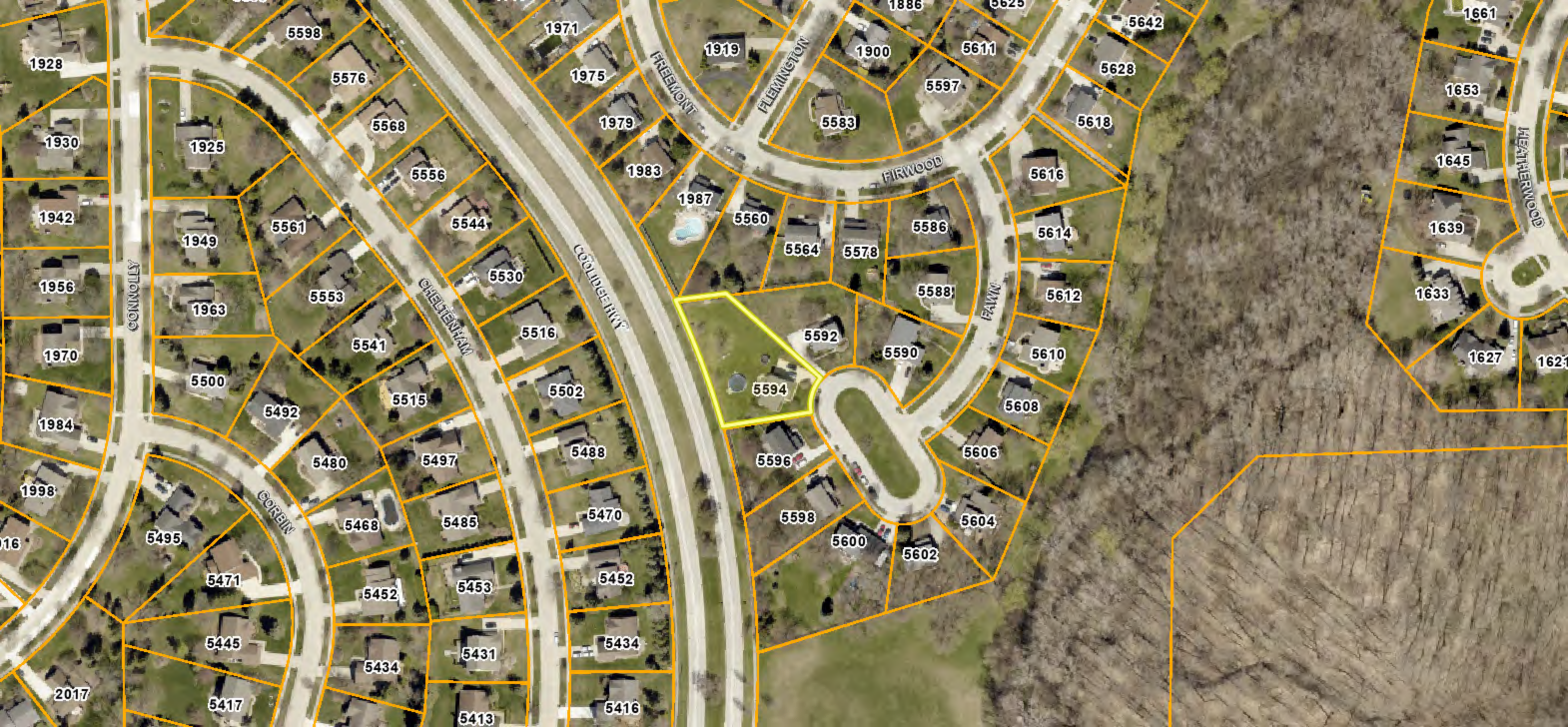

"Dangerous Animal" - A wild or feral animal, other than a dog or cat, which because of its size, aggressive nature or other characteristics constitutes a danger to persons or property.

"Wild Animal" – An animal that is not defined in this Chapter as a dangerous animal, domestic animal or house pet.
