I am writing to respectfully request permission to raise chickens in the fully enclosed backyard of my selfowned property, 2069 W Wattles Rd, Troy, MI 48098, for the purpose of providing pets to my children and as educational tools. As a parent and a resident of this community, I believe that raising chickens can provide a unique and valuable experience for children, while also promoting a more sustainable and environmentally conscious lifestyle.

Chickens are known for their friendly and social nature, which makes them ideal pets for children who want to learn about animals in a safe and nurturing environment. My intention is to provide a safe and nurturing environment for the chickens, and to use them as pets for my children and other local children. In addition to providing pets, I also plan to use the chickens as an educational tool for children. I believe that by teaching children about where their food comes from and how to care for animals in a humane and responsible manner, we can promote a more sustainable and environmentally conscious community. ## Chicken Waiver

I am writing to apply for a waiver to be able to house 4-6 chickens on my property. I know that the requirement is a minimum of 0.75 of an acre and my property is only a little bit below that, coming in at 0.64 of an acre, and I am asking that since the difference is such a small amount that this requirement can be waived and not stop us from getting chickens. I have done a lot of research into what is required to house chickens and I believe that I can do a great job in making sure they are cared for properly and humanely. I am going to built a coop and enclosure that will be sturdy and not only give the chickens enough space to be happy and healthy but also keep them safe from know predators in the area. Attached to the coop will be a large enclosed outdoor area to give the chickens ample space to forage but also be kept safe. I have also looked into the best feed that can be given to chickens to ensure that they grow healthy and lay the most nutritionally dense eggs possible. That brings me to one of the main reasons that I am looking to get chickens and that is for the eggs. Research shows that eggs bought from the store are not as nutritious as eggs that you could have in your own backyard where you know exactly what the chickens are eating and are not crammed together but have space to roam. I also have a couple of children that suffer from skin issues and I have noticed that diet plays a large part in how many flare ups they have and having my own organic eggs will be another thing I can do to ensure optimal health for my children. Aside from the obvious health benefits chickens are also very important for controlling insects in my yard. I plan to place the coop/enclosure near my garden so that the chickens can keep the amount of pests that attack my garden down to a minimum. Lastly having chickens can be used as a huge educational tool. I currently homeschool my four children
and the chickens can be used to teach the children many things from caring properly for an animal to the responsibility of having to care for an animal. I have also spoke to the HOA in my neighborhood and they have no issues with us getting chickens and are actually very encouraging and excited about the idea of us having chickens. Lastly we are also planning to put a privacy fence up enclosing the whole backyard, which will provide even more protection of the chickens and privacy for the surrounding neighbors.

I have also looked into common concerns that usually arise with chickens and I can address all of them. One of the first issues is the space. I am looking at getting 4-6 chickens and found that they require a minimum of 2-3 square feet per bird. Based on the amount of property I have there is ample space in my yard for a coop as well as an attached enclosed run to allow plenty of space for the chickens to be more than comfortable and leave plenty of space in my yard left over for my kids to run around. Another issue that I have come across is the noise level. I have done a lot of research and there are hundreds of different chicken breeds out there. As I am looking to have chickens mainly for the eggs I have come across a few different breeds that not only lay well but also are relatively quiet and are known to be more docile and not cause any trouble. I also will definitely not be getting a rooster, as I know they are not allowed in the city of Troy. Another complaint that I have heard is common with chickens is the odor. Again I have researched a way to combat this problem by providing a particular litter method for the coop/run that will leave the chicken area almost odorless. Another thing that was brought to my attention is the concern for pests. I have spoken with many people that currently have chickens and believe that with proper cleaning/keeping of the coop, proper and secure storage of the food, and a solid enclosure around the chickens
area I should be able to avoid any unwanted pests. Lastly, a concern that was raised by a neighbor was the idea that having chickens could decrease the value of surrounding properties. Again, I have done research in regards to this and found that there is no evidence to show that property values could go down. The opposite is actually true and a recent article that studied this issue showed that having chickens in the neighborhood was actually seen as a positive and people enjoyed having them around and there was no effect on property value at all.

# APPEAL FOR BACKYARD CHICKENS

## Animal Controls Appeal Board

Dear Board Members,
My name is Saadat Faiz, and I am a current graduate student at Miami University pursuing an M.A. in biology. I am formally requesting a waiver to keep chickens on our property, 963 Banmoor Drive, Troy, Michigan. In the spring of 2020, I purchased four chicks of the Rhode Island red breed from a Tractor Supply Company. Due to the wonderful experiences and successes that came from raising these chickens in our backyard, I purchased four more chicks from a Tractor Supply Company toward the end of summer that same year (this time of the barred rock breed). At the time, I was not aware that permits were required to keep these animals in my backyard. I did not know this until I had to discontinue keeping chickens due to a complaint the City of Troy received from one of our neighbors. I am far more knowledgeable on these matters now and intend to follow all procedures to raise backyard chickens in a manner that does not disturb my neighbors in any way. I do not know the nature of the complaint about my chickens. However, I am almost positive it concerned our loudest chicken, Rocky. Rocky was one of the four barred rock chicks I purchased. When I purchased these chicks, I made sure to buy only female birds. But little did I know that one of the barred rocks I purchased was a male. This was a mistake on Tractor Supply Company's behalf. A male chick must have mistakenly been placed with all the female chicks in the brooders where they were being sold inside the store because, to our surprise, Rocky grew to be a boisterous rooster instead of a hen! My family and I raised the chicks together and, in the process, bonded heavily with two of them; one of the Rhode Island red hens with a very sweet personality and our barred rock rooster, Rocky, who was simply hilarious and fun to be around. Thus, it was quite emotionally difficult when we had to rehome these two particular chickens and process the rest of the birds (for our consumption), even though our backyard chicken operation was thriving and our chickens were laying eggs consistently. I fully understand why someone would complain about the presence of a rooster in our neighborhood, as Rocky was quite loud at sunrise on certain days. I take full responsibility for not having him relocated upon discovering his true gender. The problem was that my family and I grew to truly love Rocky.

I am confident that the unintended presence of a rooster was the only problem in our entire backyard chicken project. If this appeal is accepted, I can confidently ensure there will be no roosters on our property. Just hens, which are considerably quieter and do not make extremely loud calls at sunrise. In fact, the hens we had were silent at sunrise. Throughout the day, the hens would vocalize occasionally but nowhere near as loud as a rooster. Without a rooster in our flock this time around, any form of loud noises disturbing our neighbors will not be an issue. One aspect of our property that sets us apart from nearly every other property of our size (less than .75 acres) is the incredible amount of privacy provided by our trees. The arrangement of trees on our property is similar to how a fence would be arranged to surround and conceal a property. The chickens are completely concealed by the foliage from anyone driving into our subdivision. It
requires them to stop at just the right angle and stare for a long while to make out the silhouette of our chicken structures. Even in the winter, our chickens are quite concealed, as most of the trees shielding our backyard from view do not drop their leaves in the winter. Our property is also located in an area that has fewer predators, as it is quite close to Crooks Road. It is the perfect balance of staying close enough to civilization to deter predators while also keeping our backyard almost entirely concealed from view. We have already accumulated a significant amount of experience in the overall process of raising chickens in a way that complies with all of the Board's criteria and more.

## HOUSING STRUCTURES AND ENCLOSURES

We plan to construct a stationary coop and run, a movable coop and run, and a chicken tractor for a total of three separate housing structures. We plan to keep eight chickens at most. The chickens will be kept and rotated throughout a total of three high-quality structures depending on the weather and the condition of the plants they are being kept on. We plan to establish a regenerative farm system in our backyard in which the animals, plants, fungi, and soil life all benefit one another ecologically. At no given moment will chickens be housed outside of these three completely escape-proof structures; the stationary coop and run, the movable coop and run, and the chicken tractor. We plan to construct movable structures to prevent our grass and plant communities from being overgrazed by our chickens. We use no chemical fertilizers in our backyard. This is so our chickens will not consume any fertilizer, as they consume a lot of grass and plants as a part of their natural diet. As you may know, little can be done to prevent chickens from consuming grass (apart from housing them away from nature). This is where movable chicken structures truly shine. By moving a chicken housing structure from an area of partially grazed grass to an area of lush green grass, the chickens will always have access to fresh grass and bugs, and the previous patch of grass they were on will have time to regrow and recover. In fact, grazed patches of grass often grow back even healthier and more vibrant than they were before! This is the result of working with Earth's incredible natural systems.

## STATIONARY CHICKEN COOP AND RUN

We plan to construct a large stationary chicken coop with a large chicken run attached to it. This coop will be absolutely escape-proof, predator-proof, and well-insulated. It will have a door with locks. There will also be a closeable opening near the top to allow for airflow and ventilation on hotter days and to prevent bacterial growth inside the coop. We plan to construct this with wood and materials from Home Depot. We plan to construct a roof of poultry netting and attach it to this stationary coop. The roof is to prevent chickens from flying out over the top of the chicken run and to protect them from hawks and other aerial predators. The chicken run will be large and spacious and include a wide variety of plant species growing within it. This is to provide the chickens free access to consume mint, dandelion, clover, and much more. Our goal is not only to raise these animals humanely but also to simulate what their lives would be like in nature. Since we do not have a fence on our property, I plan to eliminate all chances of our chickens walking out of our property by not allowing our chickens to free range outside the three escape-proof housing structures.

## MOVABLE CHICKEN COOP AND RUN

We plan to construct a large, movable chicken coop with a chicken run included in the blueprint. There are many of these available online, and we plan to purchase the "Large Metal Chicken

Coop Walk-in-Poultry Cage $9.2^{\prime}$ L x 18.4 ' W x 6.4 ' H . After assembling this movable chicken coop, we plan to modify and upgrade this structure to our needs (such as replacing the tarp portion with wire fencing) to enhance its long-term durability. We intend to build a coop inside this structure. Chickens will have access to fresh water, grit, oyster shells, and feed at all times and a shaded area to escape the sunlight during hot days. On cold fall and winter days, we plan to keep them in the stationary, well-insulated chicken housing structure with a heater. The chickens will be housed in the movable chicken coop periodically throughout spring, summer, and early fall (throughout much of winter, they will be kept in the stationary coop with a heater).
Whenever they have overgrazed the plants in the stationary chicken housing structure's chicken run, they will be transferred into the movable coop and run. This will allow the overgrazed plants to regrow and recover while also allowing the chickens to have access to fresh plants in which they can find bugs and peck at the flowers and leaves, and express their natural characteristics.

## MOVABLE CHICKEN TRACTOR

The second structure we intend to construct is a movable chicken tractor. By periodically moving chickens to a different part of our backyard, our grass will never be overgrazed. The moving procedure is remarkably simple and can be done by a single person. Another purpose of this chicken tractor is to allow yet another housing option in case a fight breaks out between our chickens (which is a possibility on any farm), and we can separate chickens if need be. Or if one of the chickens becomes ill or faces any health concern whatsoever, we will use the chicken tractor as a quarantine enclosure to provide extra attention and care to a chicken that requires it at any given time. The two movable structures will be protected against predators with electric poultry netting. We will keep the electricity turned on at night. We will constantly be going in and out of the backyard throughout the day to care for the chickens and manage our gardens. Thus, there will be no need to have the electricity turned on during daylight hours.

I would like to briefly explain one of the greatest benefits of having mobile chicken housing structures. Rotating chickens throughout our grass in the chicken tractor will do wonders to promote biodiversity in our soils, as chicken manure is a great natural fertilizer. It will also help our soil sequester carbon from the atmosphere. This method of rotational animal agriculture was popularized by renowned American farmer and author Joel Salatin. I am a fan of his and have read many of his books. I am passionate to the point of being genuinely obsessed with regenerative animal agriculture. I've read books and watched documentaries on farmers such as Will Harris, Alan Savory, Nicole Masters, and many more sustainable farmers. I continue to learn and adopt new farming techniques that make natural farming systems simultaneously more efficient and better for the planet. Not to mention, as foods from industrial farming methods become less nutritious and more harmful over time, the natural foods produced on regenerative farms become healthier and more nutrient-dense over time as the regenerative farming systems are refined and improved over time!

## NEIGHBORS

In no way will our chickens be a detriment to our neighbors. The structures are completelyescape proof, and we will never house our chickens outside of our structures. There will be no roosters in our flock, so loud noises will not be an issue whatsoever. As a matter of fact, two of our neighbors are actually waiting to see our chickens, as they have small children who are fascinated by animals! There is no question that the public will be protected from our animals. Our chickens will be housed in escape-proof structures at all times. The structures themselves
will be moved to different areas of our grass, with the birds safely inside. Our chickens will be protected from the public as well. We are often in our backyard, either caring for the chickens or working on our garden. There are always pending projects that require our attention, and we are in the backyard very often. Also, much of our property is kept hidden from view by many large trees that are arranged in a fence-like pattern.

## HUMANE TREATMENT

We love animals and will be treating these chickens very humanely. Chickens will always have access to the outdoors and will never be housed in small cages. Not only will we treat them humanely, but we also will, as Joel Salatin says, allow our chickens to "express their chickenness" by encouraging them to live their lives in unison with nature. They will always have access to fresh plants and insects during the spring, summer, and fall months. And during the winter, we have found a way to easily maintain temperatures of 40 -plus degrees Fahrenheit inside coop structures, even during extremely cold days, by insulating the structures well and using a heater. Throughout winter, we will feed them organic feed and organic kitchen leftovers that are not only safe for their consumption but very good for their health as well! We have never had a single problem with our chickens getting diseases. We feed them a popular brand of feed and start off our chicks on a medicated Purina chick starter. This is to prevent our chicks from getting coccidiosis disease while they are young and vulnerable and give them a head start in their lives as they grow into healthy, beautiful adult hens.

## CONCLUSION

I can honestly state that my life has felt far less fulfilling without the freedom to raise animals on this property. I have had boundless love and obsessive interest in all manner of animals for as long as I can remember. Especially birds. Keeping chickens in my backyard did wonders not only for my physical health (as our chickens provided us with a consistent supply of very healthy eggs due to the nutritious natural diet and lifestyle we offered them) but also for my mental health. It did more for my mental health than anything else I've experienced in my life. The presence of chickens in our backyard would provide us with a source of fresh eggs. It would also allow me to create videos and upload them to my YouTube channel, Wild Primal. I treat my YouTube channel as not a hobby but a business. Lastly, backyard chickens would allow friends and family to have an extraordinarily great time and an exquisite educational experience every time they visit us.

I have been tired of living disconnected from nature and am constantly seeking land to purchase. However, I also love the city of Troy and realized that most of my problems would disappear if I could simply raise chickens in my backyard. Raising chickens again would truly allow me to do what I love once again.
