WHEREAS, Robertson Brothers Homes proposes the new construction of a residential development called Village of Troy located at East Long Lake and Rochester Road; and,

WHEREAS, The proposed redevelopment includes the construction of 56 two-story townhomes, 70 three-story townhomes and 20 detached, single-family homes. The estimated capital investment is \$68,000,000. It is estimated that 1,269 construction jobs will be created. The development will assist with the anticipated demand for housing in Troy; and,

WHEREAS, Troy City Council has determined that the property is eligible as blighted property, since it has substantial buried subsurface debris present so the property is unfit for its intended use; and,

WHEREAS, Troy City Council has determined it meets or satisfies a public purpose, which may be to provide desired housing, or to eliminate blight, or to remove the substantial subsurface demolition so that the property can be used for its intended use; and,

WHEREAS, Eligible activities for this project under the Brownfield Redevelopment Financing Act include Pre-Approved Activities, Department Specific Activities, Demolition, and Preparation and Implementation of a Brownfield Plan and Act 381 Work Plan; and,

WHEREAS, The City established the City of Troy Brownfield Redevelopment Authority (TBRA) pursuant to the Brownfield Redevelopment Financing Act, Michigan Public Act 381 of 1996, and as amended for the public purpose of promoting the revitalization of environmentally distressed and blighted areas within the boundaries of the City of Troy; and,

WHEREAS, The Troy Brownfield Redevelopment Authority provides project assistance through the reimbursement of eligible activities through tax increment financing; and,

WHEREAS, Incremental taxes on real property included in the redevelopment project will be captured under this Plan to reimburse eligible activity expenses. Tax increment revenues for Brownfield Plan #11 would reimburse the costs of eligible activities in the estimated total amount of **\$2,451,359**; and,

WHEREAS, The Local Brownfield Revolving Fund (LBRA), formerly named a Local Site Remediation Revolving Fund (LSSRF) for five (5) years following developer reimbursement or until maximum capture is reached, is estimated at **\$2,451,359**. The funds deposited into the LBRF as part of this plan will be used in accordance with the requirements of ACT 381, as amended; and,

WHEREAS, That the Troy Brownfield Redevelopment Authority recommends to the City Council at its May 24, 2023 Special Meeting that the Brownfield Redevelopment Plan #11 for the proposed Village of Troy development located at the Southwest Corner of East Long Lake and Rochester Road, Troy, Michigan, be approved;

THEREFORE, BE IT RESOLVED, That Troy City Council hereby **APPROVES** the Brownfield Redevelopment Plan #11 – Village of Troy located at the Southwest Corner of East Long Lake and Rochester Road, contingent upon any required approvals needed from the State of Michigan.

#### J-6 ACH Policy and Electronic Transactions Policy

Resolution #2023-06-095-J-6

RESOLVED, That Troy City Council hereby **ADOPTS** the following policy that shall govern the use of electronic transactions:

The following policy shall govern the use of electronic transactions and ACH arrangements for the City of Troy:

# 1. Authority to Enter into ACH Agreements and Electronic Transfer of Public Funds

The Treasurer or CFO may enter into an ACH agreement as provided by Public Act 738 of 2002, effective December 30, 2002. The City of Troy shall have adopted a resolution to authorize electronic transactions and have received a copy of the policy. Applicable definitions in the act shall apply.

An ACH arrangement under PA 738 of 2002 is not subject to the Revised Municipal Finance Act, 2001 PA 34, MCL 141.2101 to 141.2821, or to provisions of law or charter concerning the issuance of debt by the City.

### 2. Responsibility for ACH Agreements.

The Controller or CFO shall be responsible for all ACH agreements, including payment approval, accounting, reporting, and generally overseeing compliance with the ACH policy. The Controller or CFO shall submit to the City Council documentation detailing the goods or services purchased, the cost of goods or services, the date of the payment, and the department levels serviced by payment. This report can be contained in the electronic general ledger software system or in a separate report to the City Council.

# 3. Internal Accounting Controls to Monitor Use of ACH Transactions

- A. The Controller or CFO shall be responsible for the establishment of ACH agreements. The Controller or CFO shall notify Accounts Payable of those accounts to be paid by ACH or electronic transfers.
- B. Upon receipt of an invoice for payment for accounts paid by ACH, the Controller shall approve payment and notify the Treasurer of the date of debit to the City accounts. Accounts payable by this method may include utility and recurring lease payments. These payments shall be included on the report of payments to the City Council. All other invoices approved by the Controller and payable by ACH may be paid in that matter if deemed in the best interest of the City, e.g. to avoid a late fee.
- C. For payment of State and Federal payroll taxes, the Controller or designee shall initiate payment to the proper authority upon receipt of the information from the payroll department using the established EFTPS and state program.
- D. For deposits from state, county, and/or federal authorities, and from third-party payment processors, e.g. (Banks, vendors), the Treasurer or CFO shall obtain the amount of the deposit and send an advice to the Finance Department which is responsible for accounting records.
- E. All invoices shall be held by the Controller's office along with copies of payment advices.
