3. Visitors' Time

No one appeared to address the Committee on any items not on the agenda.

4. "No Parking" on Witherbee between Graefield and Norwich

Ms. Virginia Hehn of 1654 Witherbee requests that the section of Witherbee between Graefield and Norwich in Section 30 be posted NO PARKING on both sides. Ms. Hehn indicated that with cars parked on the roadway, there are vision obstructions making it very difficult to pull out of her driveway. Ms. Hehn is concerned for traffic safety and safety of pedestrians who may have vision obstructed by the parked cars. Site visits indicate that the visibility conditions are comparable to a majority of all residential streets in the City.

Ms. Hehn indicated that she would like to request partial restriction of parking on the south side, say between midnight and 6:00 AM. Her concern is that there are vans, trucks, and cars parked on the south side of the road which is already narrow. She indicated 2 cars cannot pass in the available space and that the parked cars are an eyesore giving the neighborhood a "ghetto" look.

Joe Buese of 1664 Witherbee said he sympathizes with the concerns raised, but does not see parking restriction to be the solution.

Abe Boumediene of 1517 Witherbee feels such an action would be too restrictive and that he would not support it.

Mr. Culpepper indicated that most residences have a single driveway and that it may not be possible to park all cars in driveways.

Mr. Halsey suggested that the homeowners association send letters to the residents regarding the concern. Since there is no active homeowners association, Mr. Buese and Mr. Boumediene volunteered to write letters.

5. Install "YIELD" Sign on Prince at English

Thomas Rosewame of the Department of Public Works, City of Troy, requests a YIELD sign on southbound Prince at English. He noted that there has been increased traffic due to a new residential subdivision that opened north of English, and that the intersection sight distances are not adequate.

A traffic volume study at the intersection indicated that Prince carried 456 vehicles per day, north of English. English Street is the major roadway that connects to Dequindre Road and serves as entrance to a number of residential subdivisions. English carries close to 1500 vehicles per day.

A sight distance study indicates that for safe traffic conditions, vehicles on Prince have to reduce their speeds to less than 15 miles per hour. Due to trees and shrubs planted at regular intervals, motorists on English cannot see Prince Street until they are very close, resulting in some conflicts. There is also right-of-way confusion. It is felt that the conditions on site may be improved by a YIELD sign on Prince at English. The subdivision to the north of English has a construction entry/exit via Santia Street onto Dequindre. However, once all construction is complete this will be closed, forcing all traffic to enter and exit either through Prince, to the south, or Shale, to the north.

Randy Peterson of 2838 English indicated that English, being a major entrance to the subdivision, carries a high volume of traffic, and he supports the YIELD sign on Prince, considering that Santia Street will be closed, taking more traffic onto English.

Lisa Harrison, 3850 English, also voiced concerns about children's safety and that she is in favor of the YIELD sign.

Mr. Halsey asked if the owners needed more time. Mr. Giles indicated that the changes would be completed by the first part of December, and therefore there is no need for tabling this item.






