# REQUEST TO INSTALL AN ALL-WAY STOP AT JACK AND KRISTIN.

This was requested at the July 20, 1994 meeting by area residents to control speeding on Kristin Street. At the meeting, the request was changed to the safety of the school crossing at this location.

A school crossing count was then conducted on Tuesday, September 13, 1994. (See attached.) This information was then transmitted to the Troy School District Safety Committee for review.

The School Safety Committee, by letter of September 22, 1994, has requested that an All-Way stop be installed at the intersection of Jack and Kristin to improve the safety of the school crossing.

Denise Barger spoke on behalf of the residents' request from July for an all-way stop which was tabled to allow a survey count of pedestrians and vehicles. They are still in favor of an all-way stop as indicated by the Troy School District, Beechwood Swim & Tennis Club, and the residents' petition that the community is reaching out for safety at this intersection.

Mr. Robbins noted that according to Traffic Engineering Standards the stop signs are not warranted by the numbers; however, since the Troy School District Safety Committee has expressed their desire for them, he would tend not to disagree and believes they should be considered.

Mrs. Perry asked if this is an established school crossing to which she was answered in the affirmative.

Gary Newville said that they counted 99 pedestrians crossing as compared to the City's 60.

Mr. Robbins remarked that much of the problem is created by the parents themselves. Lt. Hay, mentioned that when monitoring speed, he cannot believe the driving and maneuvering to get to the school site and feels that they need something at this intersection.

Joyce Tull strongly recommends the all-way stop, saying that without the stop signs she will not allow her children to cross at this intersection. With 385 families in the area, she said to look at the numbers that will walk if the stop signs are installed.

Charles Garofali remarked that vehicles do move very fast, tires squeal, and with the new mall, they will get more traffic.

Glenn Moore, who has lived on Kristin for 10 years, said that he echoes the others regarding the volume and speed of traffic and the need to slow it. He also supports the stop signs.

It is not just a school issue, but the Beechwood Swim & Tennis Club also, which uses this intersection in the summer, as well as bike riders, etc.

Mr. Robbins pointed out that an accident involved a bike which turned in front of a vehicle and warned that if they get an all-way stop, they cannot rely on the stop signs. Only fifteen percent of the drivers stop at the signs, the signs won't lower speed and, in fact, may increase speed. They must seriously think about driving in a residential area and caution children that stop signs are not an absolute.

Mr. Diefenbaker inquired that, if stop signs are installed and if this intersection is designated as a school crossing, can there also be safety patrol. He was told that they are there now.

Mrs. Hubbell asked about a crossing guard rather than safety patrol. It was pointed out that this would be a school issue.

Lt. Hay commented that, as to speed, radar cars will be there for the next several weeks. Mrs. Hubbell cautioned the residents to get the word out to the neighbors that the police will be there. Mrs. Tull requested the radar trailer. Lt. Hay said that he will get the trailer on Kristin as soon as possible.

Mr. Robbins, when asked if the intersection will be marked as a school zone if the stop signs are installed, said not on the pavement, but there are warning signs.

Mrs. Perry wanted it pointed out that if she votes in favor of an all-way stop, it is because it is designated for a school crossing, and is not for speed control.

There was some question as to the stop signs, if installed, replacing the school crossing signs. Mr. Robbins said that you do not have to have school crossing signs with the stop signs but the advance warning signs stay.

Mr. Cross appeared before the Committee to request this sign for his 18 month old son who has severe hearing loss in both ears. Although they watch him closely and most neighbors know about him, they have friends with deaf children who feel that the signs have helped them.

OTHER BUSINESS.

Carol Haas, Louis and Debbie Kiss, and Sandra Petho appeared before the Committee to protest the No Parking signs installed on Castleton and Saratoga, showing a petition requesting that they be taken down. They also indicated that they do not want the double yellow lines placed on the curve.

After some discussion, the Committee said that since they were unaware of the order by City Council to install the No Parking signs, they did not feel they were in a position to take any action and suggested maybe the residents should go back to City Council.

Fire Inspector Matlick reported that the timing of the traffic signal for Town Center onto Livernois only allows 2-3 cars thru each cycle.

Mr. Robbins said that he has been asked to submit an expense report for budget regarding SCATS before he leaves. It is expensive. Cameras have a useful life of only 4 years at this time.

Mr. Townson reported that there are problems with the interconnect on 14 Mile by Oakland Mall. Mr. Robbins noted that there are studies going on because they are looking at 14 Mile Road for the SCATS system. Also, there are meetings regarding a future, future project for westbound 14 Mile to southbound I-75. The current TV interconnect system is not compatible with SCATS.

Mr. Halsey stated that signal at the Big Beaver turnaround east of Rochester is out of synch. Mr. Robbins mentioned that he has complained about all of the turnarounds with no success. Also, he keeps calling about Rochester/Long Lake, John R/Long Lake and the southbound Livernois to eastbound Square Lake left turn arrow. It is an erratic system. The reintroduction of the green arrow is a favorable feature. There are still flashing lights at the turnarounds on Long Lake east and west of Livernois.

Mr. Cotsonika inquired about the Long Lake widening between John R and Dequindre. Mr. Robbins said that Long Lake from Falmouth to Carnaby would be widened in 1996 but as to when the widening would be of Long Lake from Carnaby to east of John R and then to Dequindre was uncertain.


Mrs. Hubbell proposed sending the pamphlet "Questions and Answers About Residential Speed Control" to anyone who wants stop signs.



Dear Mr. Robbins:

The Troy School District Safety Committee is in receipt of correspondence from Pam Naccarato, Schroeder Elementary School Principal, regarding traffic at the corner of Kristin and Jack streets. The issue is traffic congestion at this intersection in the morning and at dismissal time in the afternoon.

Is you may recall, problems at Kristin and Jack were addressed by the District Safety Committee in October, 1991. The District Safety Committee attempted to resolve the issue without benefit of a stop sign. Specifically, the building principal did issue a school-wide notice to parents asking them to be extra considerate when students were crossing at this intersection. It is apparent now that the principal and parents have found this to be unsatisfactory.

The Safety Committee has received your report of traffic volumes recorded on September 13, 1994. Your correspondence accompanying this report indicates volumes at crossing times to be very low.

The District Safety Committee has discussed this issue once again and has now concluded that some kind of adjustment must be made at this intersection. It is clear that the school has attempted a solution with unsatisfactory results and that those closest to the situation believe that something must be done.
