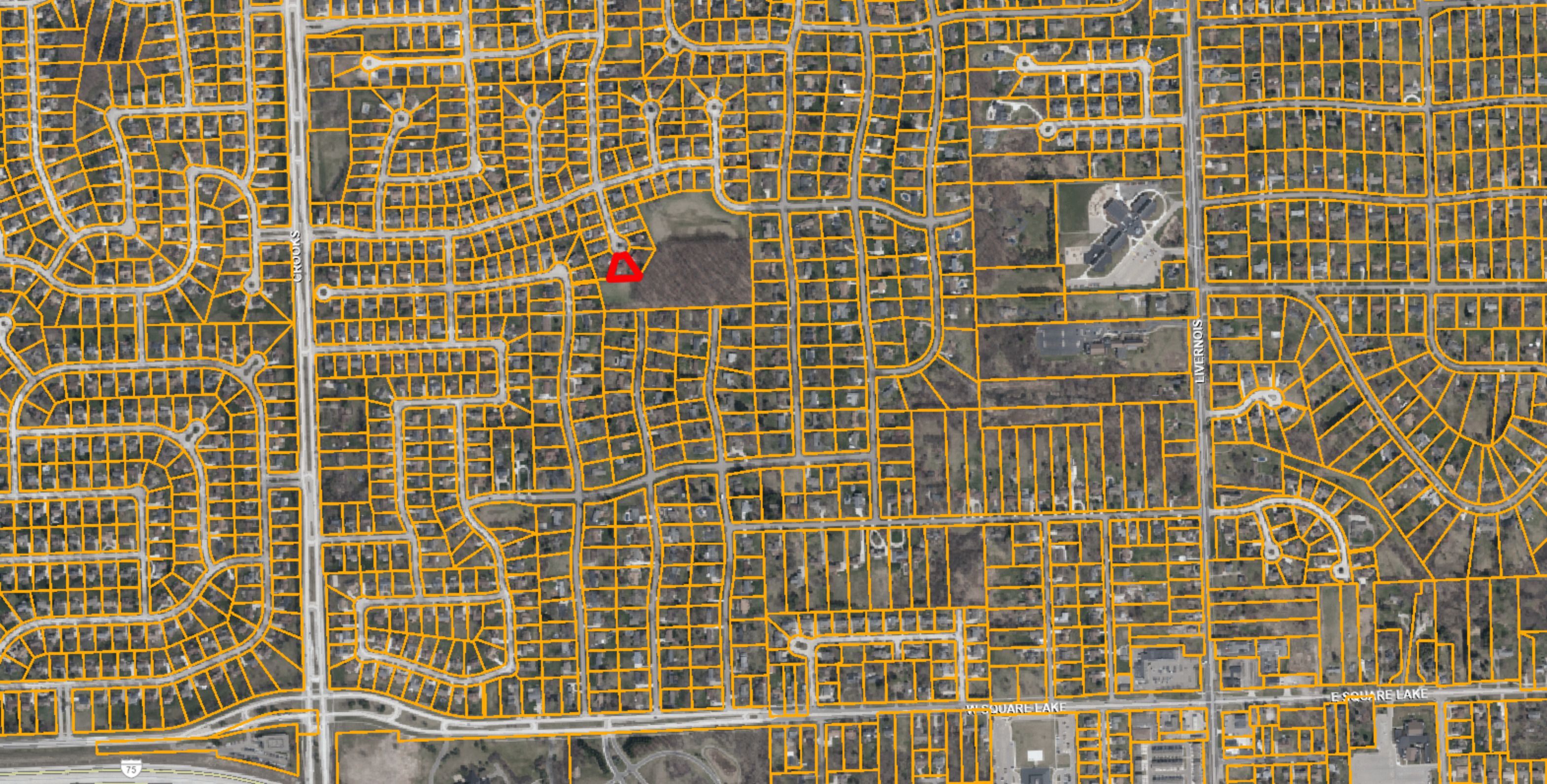

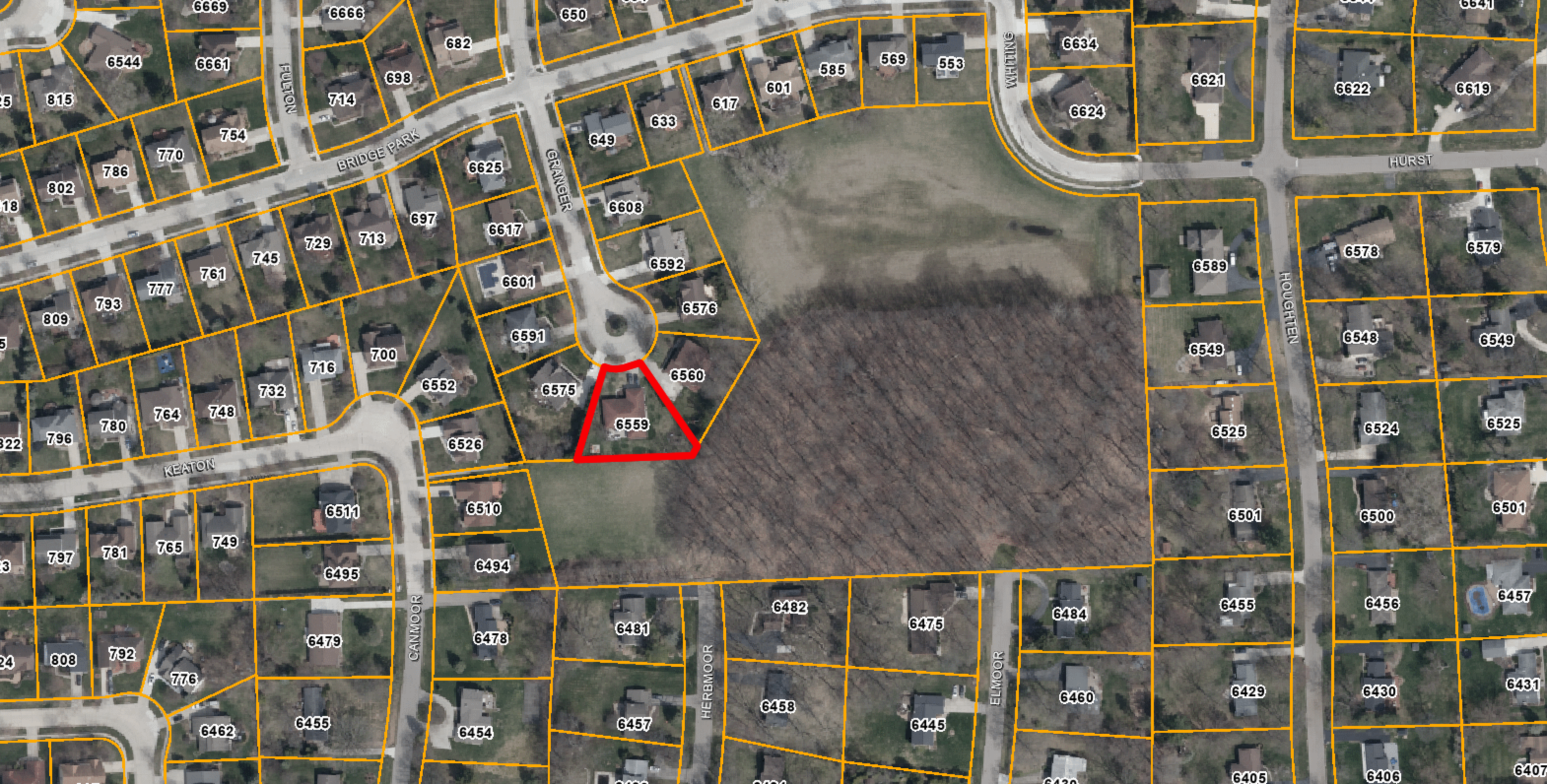



To Whom It May Concern,

I am writing you this letter to explain my need to continue to have my ducks as my emotional support animals at my home. I am the primary caregiver to both of my elderly parents and have been for years. They live with me and both have life-limiting illnesses that have been progressing rapidly. They require significant supervision day and night. I also have a full time job that has its own stressors and I do my best to make it all work. My anxiety has been at an all time high and has become debilitating. I have had to find a way to manage it enough to keep taking care of my parents and maintain my professional job. My ducks are my respite. As they live on my property, I am able to go outside and spend time with them when I desperately need a chance to breathe. They show affection, are excited to see me, and give me a chance to go through the routine of caring for them without them asking for anything more. They are my peace.

With the care that my parents require, it is rare that I can leave the house besides taking them for appointments and completing very basic errands. There is no way that I would be able to consistently participate in some kind of hobby or respite activity that would require me to leave my property for any extended period of time. Having the ducks at my home allows me to have a few moments to myself near enough to my parents that I could assist them at a moment's notice and also in my own space enough to have relief. Since I have had the ducks, my mental health has been supported enough to keep being able to do what I need to do-physically care for my parents and work to financially support them. Without the emotional support of the ducks, all of the stress would remain without the respite they safely provide. They are what help me keep it all together. Please help me to keep them so that I can mentally take on all that I need to for my family.

A little background information on the situation. All three ducks are rescue ducks since the farms would not take them being drakes and the sanctuaries are at full capacity with neglected ducks. My intentions were not to keep the ducks when they were babies, but to find a safe home. The bond and connection got stronger as time went by especially since one is disabled and required a lot more care and vet appointments. **I realized, as I saved them they ALSO have saved me!** Actually, neighborhood kids come and play with them whenever we are in the backyard. In addition, at one point the neighbor was helping last summer administrate antibiotic on one of the ducks that had a joint infection. She helped out a few days taking care of the ducks while we were out of town and the noise was not an issue.

All this time my ducks have not been an issue to anyone, especially my next door neighbor.

I'm a bit disappointed because since we treated our neighbors like family by inviting them to family events, shoveling the snow, mowing the lawn, fixing fallen mailboxes, picking them up at the airport at 5 am, grocery shopping during COVID because they were afraid to leave the house. Watching their house during the 7 months they live in Florida. This neighborhood is our home, and we enjoy participating in the community. No one from the neighborhood has addressed the concern of noise to me or my family. If I was told that was a concern I would have moved the duck set up to a different place in the backyard.

Also, my ducks are drakes which means they make almost no noise at all unless they are excited to see me or threatened by something. **They do tend to quack when the neighbor swings her driver/irons (golf) and hits the balls, at times they do fall on my yard as I'm sitting outside relaxing. I have given her the golf balls and walked away so she can have her golf time which she seems to enjoy while putting my life at risk.** Other than that they are very calm, quite, and lovable emotional support animals. **Since I was notified by the city, I have set up an additional pen for them on the opposite side of my backyard. This has resulted in three pens total, which are located at different sides of the property so the ducks are never in the same spot.** These pens ensure that the ducks are maintained in quarters constructed to prevent their escape, while also providing them with a safe space for them to graze. When I see the neighbor in her backyard I move them to be polite. Unfortunately my neighbor will never be happy, last year she texted me a very aggressive message asking why I didn't ask for her permission when I cut branches of a tree in my back yard. She would have appreciated to let her know for a tree that is in my backyard and collecting bugs.

Again, I please ask for your understanding and support during this time.

In addition, I have also noticed that she sticks her iPad between the tree branches in an effort to record the ducks quacking. The truth is, those babies do quack when they see their human mom bringing food or taking them out to play just like any other pet would.

Please don't forget, we live in the woods and our backyard is full of deer, turkeys, wild, blue jay ducks, cardinals, squirrels, coyotes and whatever decides to stop by. They all get loud but that's the beauty of nature and we just have to enjoy God's gift.

This individual never appreciated everything we did for her and her family.

Unfortunately she will never be happy, ducks are not the issue here as you can see!

Please try to understand, my life at this time is up side down, taking care full time of both parents with Parkinson's is not an easy task at all. I go for days with no sleep and my only emotional support/comfort and the only way I get a break from my painful routine is when I go and play with the ducks. I ask to please allow me to keep my ducks to help ensure my quality of life and overall mental health. These ducks provide year round support, while my neighbor only resides in the state four months out of the year.

I will try my best to describe the duck enclosure since I'm not a builder and my husband is out of town for family emergency. If you want more details you can contact the next door neighbor (who is complaining on the duck noise) since he helped build and donated most of the materials.

1st attachment: Picture of the insulated coop where they stay in the winter. It is made of scrap material, waterproof, hardware cloth for ventilation, and it stands on bricks so the water doesn't damage bottom. It is not on the ground to prevent any water damage.

2nd attachment: Run is poles and wire, covered in heavy duty clear tarp so the sun can still go in in the cold winter days.

3rd attachment: Run 2 is with gate and fish net to prevent bluejay's from drowning. There are 2 baby pools there and duckies are always supervised when they play in the baby pools.

4th attachment: Third run is also made of wire and poles and it includes XL dog crates.

In addition, I'm trying my very best to provide requested information as needed however this process is truly stressing me out. As you already know these ducks are my emotional support animals who help me through daily life which is already consumed by unforeseen concomitances that come being a full time caregiver of elderly with end of life care while trying to maintain a full time job to financially support my family. This process is truly impacting negatively my mental health which those ducks actively assist with as my emotional support and respite.

I was told more board members will be walking my premises, I ask for a day heads up since my parents with advanced Parkinson and end stage Dementia do panic when they see strangers.
