Subject:	Standard Purchasing Resolution 4: OMNIA Partners Purchasing Cooperative - 52-4 District Court Phase I LED Lighting Upgrade

## <u>History</u>

The Facilities Division of the Department of Public Works is continuing efforts to retrofit or replace light fixtures across city buildings. To date, the Facilities Division has completed LED lighting upgrades at City Hall, Library, Police Department, Public Works, parks, and several fire stations.

The current project focuses on the lighting at the 52-4 District Court. The first phase of this project includes replacing over 500 non-retrofittable light fixtures and upgrading all remaining fixtures with 4' LED tube lamps. This initiative marks the first year of a multi-year project aimed at improving energy efficiency and sustainability.

When applicable, city staff seeks DTE rebates to help offset the cost of conversion. For this phase, we are seeking approximately \$4,000 in rebates.

These upgrades align with recommendations from the Facilities Condition Assessment and Analysis and support sustainability initiatives.

Facilities staff will perform the installation and conversions.

### **Purchasing**

- Pricing to furnish lighting and installation materials at the Oakland County 52-4 District Court has been secured from *Graybar* of *Lansing*, *MI* through the Omnia Partners Contract Number EV2370 and per the detailed proposal 0247883316 Rev-2 dated February 06, 2025.
- City Council authorized participation in the Cooperative Purchasing Programs on February 5, 2024 (Resolution #2024-02-031-J-5).
