<u>History</u>

As part of a site improvement project, the City of Troy received a permanent easement for watermain from the Bharatiya Temple, owners of the property having Sidwell #88-20-06-101-016. The property is located in the northwest ¼ of Section 6 on South Boulevard, east of Adams Road.

The easement document was recorded prior to acceptance by City Council. To correct this error of procedure, staff request that City Council accept the permanent easement.

<u>Financial</u>

The consideration amount on the document is \$1.00.

Recommendation

City Management recommends that City Council accept the attached permanent easement consistent with our policy of accepting easements for improvement and development purposes.




