<u>History</u>

Developer Tableau By Mondrian has proposed the Town Haven Site Condominium development located on the south side of Wattles Road, west of Rochester. As part of the project the City of Troy received two warranty deeds for right of way and a detention facility. The City also received five permanent easements for sidewalks, water mains, public utilities and public service facilities, sanitary sewers, and storm sewers and surface drainage from Town Haven, LLC, owner of the properties having Sidwell #88-20-22-226-023 and -024.


City of Troy Planning Commission approved the 19 single-family unit development on June 11, 2024. (Resolution #PC-2024-06-035)
