The Troy Police Department annually performs undercover checks on licensed liquor establishments within the City to determine if they unlawfully sell alcohol to underage persons. The Directed Patrol Unit conducts these sting operations with the assistance of temporary employees under 21 years of age, who are sent into licensed establishments under police direction and try to purchase liquor. The Directed Patrol Unit documents each visit, and sends the information to the Michigan Liquor Control Commission (MLCC). If the decoy is sold alcohol by a licensee's employee or agent, the MLCC adjudicates the matter, providing the licensees with appropriate due process. The City also separately cites the employee who sold the alcohol to the minor.

In addition to these sanctions, the state statute also grants local municipalities the authority to object to an otherwise automatic renewal of an on-premises liquor license (restaurants, etc., where the alcohol is consumed on location). Because liquor licenses are considered property, the City needs to give each licensee notice and an opportunity to contest the allegations before taking any adverse action. Troy's due process requirements are set forth in Chapter 101 of the Troy City Ordinances. Notice is also provided to neighboring property owners.

On April 25, 2024, a bartender at Granite City Food and Brewery, located at 699 W. Big Beaver Road, failed an undercover sting operation. Pursuant to Troy's process, a public hearing notice was published and sent to the licensee. General Manager Cynthia Rivers sent an email acknowledging the violation, and detailing Granite City's actions after the violation. Her email is attached, as well as the redacted violation report, police report, MLCC disposition, and the ticket issued to the bartender. The bartender was immediately terminated, pled responsible to the violation and was fined \$200.

Based on Granite City's record, City Administration recommends that Council pass a resolution requiring responsible alcohol service training for all of licensee's serving employees. Ms. Rivers has already provided documentation of ServSafe training, which the Troy Police Department can vet to make sure that it complies with the proposed resolution.

It is likely that someone from Granite City will be present at the City Council meeting, and can answer any additional Council questions or address any of your concerns. Other persons may also want to provide public comment as to this liquor licensee.

INFORMATION: Directed Patrol Unit (DPU) Officers were conducting a liquor control compliance check at 699 W. Big Beaver Rd. (Granite City) when Decoy M.G. entered the location and was able to purchase alcohol without showing identification.

DATE/TIME: 04-25-2024 at 05:09 PM.

VENUE: 699 W. Big Beaver Rd. (Granite City). City of Troy, Oakland County, Michigan.

OFFICER OBSERVATIONS: I followed Decoy M.G. into the restaurant. I sat several seats down from Decoy M.G. at the bar and observed the entire interaction with the bartender James Krueger. Krueger asked Decoy M.G. if she wanted anything to drink. Decoy M.G. asked for a water and a Bud Light. Krueger suggested a similar beer to Bud Light. Decoy M.G. told him that would be fine. I observed Krueger then pour a beer and place it in front of Decoy M.G. without asking for her identification or inquiring about her age.

I advised Decoy M.G. to leave the bar. I then made contact with Krueger and identified myself as a police officer. I then made contact with Granite City General Manager Bianca Silua. I advised her of the violation.

STATEMENT OF DECOY M.G.: Decoy M.G. stated that she walked into Granite City and sat at the bar. Decoy M.G. stated that she asked for a Bud Light, and the bartender recommended a similar beer. Decoy M.G. states that she was given the beer without being asked for identification or about her age.

CITATION: Krueger was issued a citation for furnishing/sale to a person under 21. Krueger was advised to contact the court within fourteen days. Citation#: 24TR03167.

RECEIPT/EVIDENCE: I obtained a copy of the receipt for the transaction. It was logged into evidence and placed into the depository. A photograph of the beer served to Decoy M.G. was taken with my department issued cell phone using Axon Capture and uploaded to the evidence.com case file.

AUDIO/VIDEO REQUEST: I submitted a request for the body worn camera footage from myself and Ofc. O'Brien.

<u>CASE:</u> All LCC paperwork was completed. It should be noted that during my contact with Krueger he was genuinely upset with himself and acknowledged his mistake without excuse.



I am writing to provide a formal summary of the actions taken by Granite City Food & Brewery in Troy, MI following the incident involving former employee Michael Collett on 04/25/2024.

Granite City Troy has always prioritized the safety and well-being of our guests and community. The incident was taken very seriously, and we acted swiftly to reinforce our strong commitment to responsible alcohol service. The following measures were implemented immediately:

- 1. **Immediate Termination:** Michael Collett was released from employment immediately following the incident. This decision reflected our zero-tolerance policy for any violations related to alcohol service laws.
- 2. **Mandatory Alcohol Certification:** Granite City Inc. requires all team members who serve alcohol to complete the Alcohol ServSafe course and become certified upon hire. This ensures that every staff member is equipped with the proper knowledge and tools to serve alcohol safely and responsibly. A certificate verification sheet is attached. All management staff are also current with their Alcohol ServSafe certifications and regularly updated on policy changes through our annual compliance training.
- 3. **Ongoing Staff Education and Accountability:** We implemented routine pre-shift meetings to emphasize the critical importance of checking every guest's ID, regardless of age or appearance. These meetings also review when to involve a manager in alcohol service situations, reinforcing a culture of caution, accountability, and shared responsibility.

At Granite City Troy, responsible alcohol service is not just a compliance requirement—it is a core value that we uphold at every level of our operation. We are committed to ongoing education, consistent enforcement of policy, and creating a safe environment for both our guests and staff.
