Subject: BP Gas (John R. Petro Mart) Liquor License Violation (Introduced by: Nicole MacMillan, Assistant City Attorney and Lynn Giorgi, Police Staffing and Standards Specialist)

The Troy Police Department annually performs undercover checks on licensed liquor establishments within the City to determine if they unlawfully sell alcohol to underage persons. The Directed Patrol Unit conducts these sting operations with the assistance of temporary employees under 21 years of age, who are sent into licensed establishments under police direction and try to purchase liquor. The Directed Patrol Unit documents each visit, and sends the information to the Michigan Liquor Control Commission (MLCC). If the decoy is sold alcohol by a licensee's employee or agent, the MLCC adjudicates the matter, providing the licensees with appropriate due process. The City also separately cites the employee who sold the alcohol to the minor.

In addition to these sanctions, the state statute gives some power to a local municipality when an off-premises liquor license retailer (alcohol purchased and consumed elsewhere), but this is more limited. Because liquor licenses are considered property, the City needs to give each licensee notice and an opportunity to contest the allegations before taking any adverse action. Troy's due process requirements are set forth in Chapter 101 of the Troy City Ordinances. Notice is also provided to neighboring property owners.

On April 15, 2024, a cashier at BP Gas (John R. Petro Mart), located at 1980 E. Maple Road, failed an undercover sting operation. Pursuant to Troy's process, a public hearing notice was published and sent to the licensee. Upon information and belief, BP Gas will acknowledge the violation, as it did before the MLCC. The redacted violation report, police report, MLCC history, and the ticket issued to the cashier are attached. The cashier pled responsible to the violation and was fined \$200.

Based on John R. Petro Mart's record, City Administration recommends that Council pass a resolution requiring responsible alcohol service training for all of licensee's employees who sell alcohol.

It is likely that someone from John R. Petro Mart will be present at the City Council meeting, and can answer any additional Council questions or address any of your concerns. Other persons may also want to provide public comment as to this liquor licensee.

INFORMATION: Directed Patrol Unit (DPU) Officers were conducting a liquor license compliance check at 1980 E. Maple Rd. (BP gas station) when Decoy K.K. entered the location and was able to purchase alcohol without showing identification.

DATE/TIME: 04-15-2024 at 04:43 PM.

VENUE: 1980 E. Maple Rd. (BP gas station). City of Troy, Oakland County, Michigan.

STATEMENT OF DECOY: Decoy K.K. stated that she walked into the location and grabbed a Twisted Tea tallboy and then went to the counter. The clerk took the money she offered and then asked for her identification. Decoy K.K. told the clerk that her identification was in her car. Decoy K.K. stated that the clerk continued with the transaction and told her to bring it next time.

OFFICER ACTION: Ofc. Carioti and Ofc. O'Brien entered the location and made contact with the clerk, Motasim Billah and advised him of the violation. Billah provided a written statement.

STATEMENT OF BILLAH: Billah stated that during the transaction he asked Decoy K.K. for her identification, and that she stated that she has I.D. and that she will bring it back. Billah stated that it was too late to see I.D. as the transaction was already made. See Billah's statement for further information.

CITATION: I issued Billah a citation for furnishing/sale to a person under 21. Billah was advised to contact the court within fourteen days. Citation#: 23TR02837.

EVIDENCE/PHOTOS: A copy of the receipt for the transaction was logged into evidence and placed into the depository. A photograph of the Twisted Tea was taken using Axon Capture on my department issued cell phone. The photo was uploaded to evidence.com.

AUDIO/VIDEO: I submitted a request for the body worn camera footage from Ofc. Carioti & Ofc. O'Brien.

CASE: All LCC paperwork was completed. The Twisted Tea was dumped out and disposed of. No further action.
