Subject:	Seven Eleven Inc. and MCME Investment (5020 John R Road) Liqu (Introduced by: Nicole MacMillan, Assistant City Attorney and Lynn Staffing and Standards Specialist)	

The Troy Police Department annually performs undercover checks on licensed liquor establishments within the City to determine if they unlawfully sell alcohol to underage persons. The Directed Patrol Unit conducts these sting operations with the assistance of temporary employees under 21 years of age, who are sent into licensed establishments under police direction and try to purchase liquor. The Directed Patrol Unit documents each visit, and sends the information to the Michigan Liquor Control Commission (MLCC). If the decoy is sold alcohol by a licensee's employee or agent, the MLCC adjudicates the matter, providing the licensees with appropriate due process. The City also separately cites the employee who sold the alcohol to the minor.

In addition to these sanctions, the state statute gives some power to a local municipality when an offpremises liquor license retailer (alcohol purchased and consumed elsewhere), but this is more limited. Because liquor licenses are considered property, the City needs to give each licensee notice and an opportunity to contest the allegations before taking any adverse action. Troy's due process requirements are set forth in Chapter 101 of the Troy City Ordinances. Notice is also provided to neighboring property owners.

On April 22, 2024, a cashier at Seven Eleven, located at 5020 John R. Road, failed an undercover sting operation. Pursuant to Troy's process, a public hearing notice was published and sent to the licensee. Attorney Jason Canvasser sent a letter acknowledging the violation, and setting forth the actions that Seven Eleven has taken at this location since the violation. This letter, plus the redacted violation report, police report, MLCC history, and the ticket issued to the cashier are attached. The cashier pled responsible to the violation and was fined \$200.

Based on this Seven Eleven's and MCME Investment's record, City Administration recommends that Council pass a resolution requiring responsible alcohol service training for all of licensee's employees who sell alcohol.

It is likely that someone from Seven Eleven will be present at the City Council meeting, and can answer any additional Council questions or address any of your concerns. Other persons may also want to provide public comment as to this liquor licensee.

INFORMATION: Directed Patrol Unit (DPU) Officers were conducting a liquor control compliance check at 5020 John R Rd. (7-11) when Decoy K.K. entered the location and was able to purchase alcohol without showing identification.

DATE/TIME: 04-22-2024 at 03:15 PM.

VENUE: 5020 John R Rd. (7-11). City of Troy, Oakland County, Michigan.

STATEMENT OF DECOY K.K.: Decoy K.K states she walked into the 7-11 and grabbed a yellow Twisted Tea tall-boy and walked to the counter with it. Decoy K.K. stated that the clerk completed the check- out and never asked her for identification.

OFFICER ACTION: Decoy K.K. exited the store and turned over the Twisted Tea to Ofc. Carioti and me. I then entered the location and made contact with the clerk, Syed Saber and advised him of the violation. Saber did not complete a written statement but did acknowledge his mistake.

<u>CITATION</u>: Saber was issued a citation for furnishing/sale to a person under 21. Saber was advised to contact the court within fourteen days. Citation#: 24TR03051.

RECEIPT/EVIDENCE: I obtained a copy of the receipt for the transaction. It was logged into evidence and placed into the depository. A photograph of the alcohol that Decoy K.K. was able to purchase was taken with my department issued cell phone via Axon Capture and uploaded to the case file.

AUDIO/VIDEO REQUEST: I submitted a request for the audio/video from my body worn camera.

<u>CASE</u>: All LCC paperwork was completed. The Twisted Tea was dumped out and disposed of. The manager of the location, Cindy Baughman was not at the on scene, but I was able to speak with her via telephone and advise her of the violation.



Clark Hill PLC is legal counsel to 7-Eleven, Inc. I write in regard to the sale to minor violation that occurred at the above-referenced 7-Eleven branded store on or about April 22, 2024.

At the time of this sale to minor, this store was operated by 7-Eleven's independent contractor franchisee, MCME Investment, Inc. 7-Eleven franchisees are required to operate 7-Eleven branded stores in compliance with their franchise agreement, which, among other things, requires compliance with all applicable rules, statutes, regulations, and ordinances. 7-Eleven expects that its franchisees sell all age restricted products in a responsible manner.

This store was first issued a specially designated merchant's liquor license for the sale of beer and wine in December 1975. Since February 2006, when this location had its last sale to minor violation and the April 2024 sale to minor violation, this location passed at least 19 control buy operations.

7-Eleven's independent contractor franchisee, MCME Investment, Inc. is solely responsible for the conduct of its employees. 7-Eleven has confirmed that MCME has trained all of its employees on the responsible sale of age restricted products through 7-Eleven's robust training program, which has been approved for use by the Michigan Liquor Control Commission. That training teaches employees how to, among other things, properly ID individuals wishing to buy age-restricted products, spots signs of potential intoxication and, politely refuse sales. In addition, "WE ID" signs are posted at the point of sale and throughout the store. Further, the point of sale system requires an ID scan or that a birthdate be manually added after checking ID. Also, this store participates in the BARS program, which is a mystery shopping program designed to ensure that employees are properly checking for ID's before making an age restricted sale.

7-Eleven takes the sale of all age restricted products very seriously and believes that the above actions demonstrate its and its franchisees commitment to ensuring responsible
