Seven Eleven Inc. and Jandou LLC (2910 John R Road) Liquor License Violation Subject:

(Introduced by: Nicole MacMillan, Assistant City Attorney and Lynn Giorgi, Police

Staffing and Standards Specialist)

In addition to the Troy Police Department's annual undercover checks on licensed liquor establishments, there is also a requirement to report any other unlawful sales of alcohol to underage persons to the MLCC. If a minor is sold alcohol by a licensee's employee or agent, the MLCC adjudicates the matter, providing the licensees with appropriate due process. The City also separately cites the employee who sold the alcohol to the minor.

In addition to these sanctions, the state statute gives some power to a local municipality when an offpremises liquor license retailer (alcohol purchased and consumed elsewhere), but this is more limited. Because liquor licenses are considered property, the City needs to give each licensee notice and an opportunity to contest the allegations before taking any adverse action. Troy's due process requirements are set forth in Chapter 101 of the Troy City Ordinances. Notice is also provided to neighboring property owners.

On May 22, 2024, a cashier at Seven Eleven, located at 2910 John R. Road, unlawfully sold alcohol to several minors. Pursuant to Troy's process, a public hearing notice was published and sent to the licensee. Attorney Jason Canvasser sent a letter acknowledging the violation, and setting forth the actions that Seven Eleven has taken at this location since the violation. Most notably, Seven Eleven terminated its franchise with Jandou on or about June 7, 2024. This letter, plus the redacted violation report, police report, MLCC history (for the new licensee at the location), and the tickets issued to the cashier are attached.

Based on Seven Eleven's termination of the franchise, City Administration recommends that Council pass a resolution requiring responsible alcohol service training for all of licensee's employees who sell alcohol.

It is likely that someone from Seven Eleven will be present at the City Council meeting, and can answer any additional Council questions or address any of your concerns. Other persons may also want to provide public comment as to this liquor licensee.

I (Sgt. Parker) received 2 separate phone calls on 5/20/2024 from different parents of minors who stated that their child was sold alcohol at the 7-11 at 2910 John R.

The first caller stated that about a week ago they caught their son with a bottle of Hennessey. They checked their sons cash app and observed a purchase at the 7-11 for \$24. They also checked their son's location and observed that he was at the 7-11 at around 1600 hours. On Friday 5/17/2024 their son came home and appeared to be intoxicated. They were aware that their son was with some friends in Warren prior. When they checked their son's cash app, they seen a purchase from 7-11 for \$17 at approximately 1900 hours. On Saturday 5/18/2024 that parent went to the 7-11 and confronted a female (believed to be owner) regarding an employee selling alcohol to their minor child. The unknown female called someone on the phone and told them that they had a parent at the store stating they sold alcohol to their child. The unknown female asked the unknown employee on the phone if they had asked for ID. The unknown female then made a comment over the phone stating something to the fact, what do you mean you do not know. The unknown female then began speaking another language. The parent stated the call was not on speaker phone, so they did not know who the unknown female was talking to. The unknown female supposedly then told the parent that their child should not have been buying alcohol and must have had a fake ID.

The second caller stated that on Saturday 5/18/2024 their minor son came home with some friends, and they found a case of beer in their son's vehicle. The parent stated that they checked Life360 to check for their son's whereabouts and seen that he was at the 7-11 at approximately 2100-2130 hours on 5/18/2024. When the parent confronted their son, he admitted to getting the beer from the 7-11 and made comments that the employees know them there and do not card.

Both parents stated that their children made comments to the effect of, everyone knows that they sell there.

I went back to 2021 until present time and reviewed any tips and reports for alleged sales to minors or LCC violations. This included tobacco sales to minors as well.

TIPS:

1/28/2021: Caller caught minor son vaping. Determined that several locations including 7-11 do not check for ID's.

6/10/2021: Refused caller stated they witnessed a clerk selling vaping equipment to underage teens. They also stated that this was on on-going issue, in which a previous employee was fired for selling alcohol to minors.

8/23/2021: Two individuals during court advised a Judge that they had purchased drugs and alcohol from the 7-11.

NO TIPS FROM 2022

9/25/2023: Caller was told a by student of his that the 7-11 is selling alcohol to minors.

4/10/2024: Complainant stated unknown staff at the 7-11 is selling alcohol to underage people. Complainant believes they are selling to people they know even though they are underage. **NOTE:** DPU did attempt a minor decoy LCC inspection on 4/15/2024 with negative results.

REPORTS:

21-3135 (2/3/2021): In regard to tip from 1/28/2021. Tobacco Violation. DPU Officers utilized a minor decoy to attempt purchase of tobacco from the 7-11. Decoy was able to purchase a vape

The Officers noted that on video there are several males going in and out of the back room behind the counter but there was no video in the back room. The video showed a male walk out with a bag similar to what the caller described. Officers did not notice any open alcohol in the video or on scene. While Officers were on scene it was only and the caller on the premise.

Both we detained and advised for the reason of police contact. Both S1 and S2 said they did not wish to make any further statements. Once advised on the information that was obtained by officers during the prior traffic stops, was adamant that they ID every customer and that the minors must be using fake IDs. Inside of the store, officers could observe several interior CCTV cameras pointing at the cash register area, where all transactions occurred. It was decided that the DVR storage computer would be seized as evidence so officers could validate

Overview:

On May 22, 2024 between 1730 and 2300 hours, Sgt. Parker, Officer Carioti and I (O'Brien) continued our investigation of underage alcohol sales at the 7-11 located at 2910 John R Rd. Troy. Specifically, between 2100 and 2230 hours, I observed approximately 20-30 vehicles each occupied by one to four teenagers enter and exit the 7-11 parking lot/business. Most of these suspected <21 customers exited 7-11 carrying a black, plastic bag or a box of alcoholic beverages. Due to manpower constraints and the length of each sub-investigation, two successful traffic stops were completed.

As daylight faded most license plates were unreadable from my vantage point. However, the behavior pattern of most of the suspected <21 customers was very similar and easily identifiable. For instance, a group of suspected <21 customers would enter 7-11 together. If an >21 customer was inside the business, the <21 customers would loiter until that person(s) exited. After which, the <21 customers would make their selection and pay. After paying, each suspected <21 customer would briskly walk or run to the vehicle in which they arrived. If a vehicle arrived with four occupants, each occupant would exit the business individually immediately after paying. I experienced this on 5-22-24 when I was inside 7-11 and several teenagers were loitering inside.

Documented below are noteworthy observations but they do not represent the amount of vehicles/<21 customers that arrived and made suspected underage alcohol purchases on the evening of 5-22-24.

Dear Ms. MacMillan:

Clark Hill PLC is legal counsel to 7-Eleven, Inc. I write in regard to the sale to minor violation that occurred at the above-referenced 7-Eleven branded store on or about May 22, 2024.

At the time of this sale to minor, this store was operated by 7-Eleven's independent contractor franchisee, Jandou LLC. 7-Eleven franchisees are required to operate 7-Eleven branded stores in compliance with their franchise agreement, which, among other things, requires compliance with all applicable rules, statutes, regulations, and ordinances. 7-Eleven expects that its franchisees sell all age restricted products in a responsible manner.

As a result of Jandou LLC's failure to comply with its obligations under its franchise agreement, Jandou LLC's franchise agreement was terminated on or about June 7, 2024. Since that time, this store has been operated by 7-Eleven corporate employees.

7-Eleven trains all of its employees on the responsible sale of age restricted products. 7-Eleven's robust training program has been approved for use by the Michigan Liquor Control Commission. That training program teaches employees how to, among other things, properly ID individuals wishing to buy age-restricted products, spots signs of potential intoxication and, politely refuse sales. In addition, "WE ID" signs are posted at the point of sale and throughout the store. Further, the point of sale system requires an ID scan or entry of a birthdate after checking ID. Also, 7-Eleven participates in the BARS program, which is a mystery shopping program designed to ensure that employees are properly checking for ID's before making an age restricted sale.

7-Eleven takes the sale of all age restricted products very seriously and believes that the above actions demonstrate its commitment to ensuring responsible sales of age restricted products, including alcohol products. This is further demonstrated by 7-Eleven's passed control buy on March 1, 2025 at this store.
