M. CITY COUNCIL/CITY ADMINISTRATION RESPONSE/REPLY TO PUBLIC COMMENT FOR ITEMS NOT ON THE AGENDA FROM TROY RESIDENTS AND BUSINESSES:

Mayor Baker responded that it has been the policy of the City for decades that homeowners may be responsible for replacing sidewalks. DPW Director Bovensiep commented that there is not a fund at the City of Troy to cover sidewalk replacement, and he explained the nuances of how costs are shared by residents for sidewalk replacement.

Mayor Baker commented that he also discovered a ghost page with bond information on it, and it seems to be a Google cache issue.

City Attorney Bluhm commented that Chapter 49 does not allow for variances, and the purpose of the restriction on food trucks in restaurant parking lots is to prevent competition with brick-and-mortar establishments. There was discussion on the origination and purpose of the Mobile Food Vending Unit ordinance.

Council Member Brooks asked about the water testing at the pools and if it includes cryptosporidium. Council Member Chamberlain-Creanga said the information about testing at the pools was included in a previous City Council questions and responses. City Manager Nastasi said City management will provide a report with an update on the testing procedures at the pools.

Council Member Hodorek commented about the bond proposal website and the dialogue on social media. She urged residents to research the information to make sure it is accurate before putting the information on social media. She also urged residents to attend the informational sessions when they are offered. City Manager Nastasi said that the schedule for the town halls will be coming out soon and will be available on the website and social media. City Manager Nastasi said the events will be on different days at different locations so they can reach as much as the community as possible. Mayor Baker said there is a link to the bond webpage on the City's main homepage at www.troymi.gov. Council Member Hodorek urged residents to take advantage of the expertise of Chief Financial Officer Maleszyk, who has private and public sector experience and is really good at explaining the workings of municipal finance.
