- a) Resolution Imposing Temporary Moratorium on Issuance of Building Permits for Medical Marihuana Grow Operations Under Michigan Medical Marihuana Act

WHEREAS, the City of Troy, Michigan, by ordinance has prohibited the possession and use of marijuana; and

WHEREAS, the use, possession, cultivation, manufacture or sale of marihuana remains a crime under the laws of the State of Michigan and the United States of America; and

WHEREAS, the People of the State of Michigan by referendum provided that there shall not be state or federal criminal prosecution for medical use of marihuana in specific and limited ways as provided in MCL 333.26421*et seq.* (Michigan Medical Marihuana Act, hereafter MMMA), and therefore the City is prevented from enacting an absolute preclusion of medical marihuana grow operations and use in the City of Troy, as long there is compliance with the terms of the MMMA; and

WHEREAS, after the enactment of the MMMA, the Michigan Supreme Court in *Ter Beek v City of Wyoming* clarified that reasonable municipal regulation of the cultivation of medical marihuana, in furtherance of health, safety, and welfare concerns, is permitted under the MMMA; and

WHEREAS, the Troy City Council has been apprised that there are currently several individual marihuana grow operations (over 50) which saturate the City of Troy, and is concerned that due to the restrictions in the MMMA, the City is impeded in its ability to verify that all of the several medical marihuana grow facilities are in compliance with the MMMA after the issuance of the building permit; and

WHEREAS, the Troy City Council believes that the issuance of building permits for any additional marihuana grow facilities above the significant number already present in the City of Troy creates a situation that could have a harmful impact upon the citizens of Troy unless regulations can be established to assure strict compliance with the limitations set forth in the MMMA and mitigate the harmful impact to the health, safety and welfare of the community; and

WHEREAS, there are no viable pending applications for medical marihuana grow facilities in the City of Troy.

NOW THEREFORE,

BE IT RESOLVED that as of this date (April 10, 2017), the Troy City Council issues an immediate moratorium, prohibiting the City from issuing any additional building permits for medical marihuana grow operations under the MMMA for a period of 180 days to allow City Council to consider additional regulations that are designed to minimize the detrimental impact to the health, safety and welfare of the citizens of the City of Troy.

BE IT FURTHER RESOLVED, that the Troy City Council directs City Administration to prepare proposed regulations that would strengthen the City's ability to ensure that all individual medical marihuana grow operations in the City are compliant with the MMMA, which may include licensing and regular inspection provisions for all medical marihuana grow operations, including those already permitted in the City, and required verification procedures for registered patients and caregivers, as well as any other provisions that are allowed under the amended MMMA; and

BE IT FINALLY RESOLVED that the Troy City Council directs City Administration to take any allowable actions to ensure that existing medical marijuana grow operations remain in strict compliance with the MMMA.

b) Resolution Expressly Opting Out of All Medical Marihuana Facilities Under the Medical Marihuana Facilities Act

WHEREAS, the City of Troy, Michigan, by ordinance has prohibited the possession and use of marijuana; and

WHEREAS, the use, possession, cultivation, manufacture or sale of marihuana remains a crime under the laws of the State of Michigan and the United States of America; and

WHEREAS, the People of the State of Michigan by referendum provided that there shall not be state or federal criminal prosecution for medical use of marihuana in specific and limited ways as provided in MCL 333.26421*et seq.* (Michigan Medical Marihuana Act, hereafter MMMA); and

WHEREAS, in addition to the MMMA, the Michigan Legislature has enacted MCL 333.27101 *et seq.* (Medical Marihuana Facilities Act, hereafter MMFLA) providing municipalities with a choice to adopt ordinances allowing for up to five unique commercial marihuana facility types, as set forth in the MMFLA; and

WHEREAS, the MMFLA prohibits these commercial medical marihuana facilities unless the municipality in which the facility is proposed to be located expressly adopts an ordinance allowing for each such commercial MMFLA facility; and

WHEREAS, under the MMFLA, licenses for commercial MMFLA facilities will not be accepted by the State of Michigan until December 2017, but in the interim, Troy City Administration has received many inquiries about the City of Troy's official position, which is determined by the Troy City Council; and

WHEREAS, the Troy City Council believes that the potential effects upon its citizens, by the commercial sale, cultivation, production, transportation and storage of medical marijuana could adversely affect the public safety, health and welfare of its citizens if commercial medical marihuana facilities, as defined by the MMFLA, are allowed in the City of Troy.

NOW, THEREFORE BE IT RESOLVED that the Troy City Council believes that it is in the best interest of the citizens of the City of Troy to preclude all five types of commercial medical marihuana facilities, as set forth in the MMFLA, from the City of Troy. The City of Troy City Council is not willing to adopt an ordinance allowing for any commercial medical marihuana facilities as set forth in the MMFLA.
