ICMA/RC Investment Review

- Jason, Kevin and Rola from ICMA/RC introduced themselves.
- Kevin presented the Investment Review, reviewed the ICMA/RC Investment Objective and Philosophy and talked about the Active Vantagepoint and VT Funds and their performance.
- Jason talked about Employee Education and the three representatives from ICMA/RC that will work closely with employees and presented the Plan Health Monitor.

Investments

Graystone Consulting Group Presentation

- Market Review Bob Alati
 - Bob talked about profit margins, the Gold and Copper Charts and the S&P charts, highlighting the factors that are indicating that the markets are accelerating.
 - He concluded that we are still in a bull market and there are no indications of a recession at this time.

• Investment Review - Tim Brice

- Tim discussed the On the Markets article indicating that they believe there will be a recovery in the global economy next year and that the US GDP growth will stabilize.
- He concluded that they will continue with the Reflation theme by being overweight to international equities and US Value stocks.
- He reviewed Portfolio Performance noting the YTD Net Returns Net of Fees for the combined accounts as of November 30th, 2019 was 16.24%.

UBS Financial Presentation

- Market Review Rebecca Sorensen / Darin McBride
 - o Darin talked about their key thoughts as we enter 2020 and for the next decade.
 - o Increased coordination between governments and central banks could spur either greater global growth or end in inflationary catastrophe.
 - o They anticipate lower returns and higher volatility for most financial assets.
 - o Investors may need to increase their exposure to equities or accept lower returns.
 - Darin also discussed the Year Ahead 2020 article discussing investing decisions for 2020 and the key issues for investors.

Investment Review – Rebecca Sorensen / Darin McBride

 The performance as of November 30th, 2019 YTD Net Rate of Return Net of Fees was as follows: Combined 21.49%; ERS 20.29%; NAIC 25.98%.

 - Invest cash from sales in Vanguard Large Cap Value ETF
- The ERS Rules and Regulations Manual was referenced by the Chairman in regards to his suggestion that no purchase or sales should be done in the NAIC account if it has not been recommended by the NAIC Investment Advisory Service report.
- The Board agreed with the Chairman and decided not to take any action on the NAIC Portfolio recommendations by UBS at this time until further notice.
