Subject: Troy Family Aquatic Center

#### Introduction

The projects and other tasks necessary to prepare the Troy Family Aquatic Center (TFAC) for opening in 2021 are described in a memo dated September 17, 2020. The purpose of this memo is to provide additional information so the City Council may provide City staff with direction regarding whether to proceed with the projects necessary to prepare for opening.

### **Pool Repairs Project**

The Troy Community Center pools and Troy Family Aquatic Center pools require plaster repair and resurfacing approximately every five or six years. The Community Center pools were last repaired and resurfaced in 2014 and the Aquatic Center pools were last repaired and resurfaced in 2015. In 2019, both pools had deteriorated to the point where they required repair and resurfacing again so City staff prepared a bid solicitation for these services.

The City posted the bid solicitation on the Michigan Inter-governmental Trade Network (MITN) website and emailed it directly to four companies. Two (2) companies attended the pre-bid meeting and had the opportunity to visit the pools. Only one (1) bid was received when the bid opening was conducted on January 23, 2020. Pool companies that did not respond to this bid opportunity indicated that the City's Scope of Work was too large and the timeline was too short to complete the job. The original timeline included beginning the project in April 2020 and completing it in time to open Memorial Day weekend.

On February 10, 2020, City Council awarded the contract to the sole bidder and approved a FYE 2020 budget amendment increasing Aquatic Center Fund capital expenditures from \$100,000 to \$126,085 (Resolution #2020-02-038). The project did not begin in April 2020 as planned due to the COVID-19 pandemic. On June 22, 2020, City Council re-appropriated \$127,000 so the project could be completed in FYE 2021 (Resolution #2020-06-088). City staff intended to begin the project in April 2021 and complete it in time to open Memorial Day weekend, as had been the original plan. However, the contractor notified the City it could not perform the work in the spring of 2021 and would have to do it in the fall of 2020.



# **City Council Action**

The City Council may provide City staff with direction to proceed with the pool repairs in the contract City Council awarded on February 10, 2020. In that case, the contractor will perform the work in October and City staff will proceed with the other projects and other tasks necessary to prepare the Aquatic Center for opening in 2021. Alternatively, the City Council may provide City staff with direction to postpone the pool repairs. In any event, City staff will use the upcoming community survey and other opportunities to engage the community as it investigates options to replace the Aquatic Center with an updated facility in the future.

#### **History**

- The Troy Community Center Pools and the Troy Family Aquatic Center pools require re-marciting every five to six years.
- The service was last performed in 2014 for the Community Center Pools and 2015 for the Troy Family Aquatic Center Pools (TFAC).
- Both pools are showing serious deterioration and need the service provided to ensure the facility's stability and patron safety.
- This will be the third time the Community Center Pools have been re-marcited and the seventh time for the TFAC pools since their existence.

#### **Purchasing**

 On January 23, 2020, a bid opening was conducted as required by City Charter and Code to furnish all equipment, material and labor to re-marcite pools and also re-grout tile in pools at the Troy Community Center Pools and Troy Family Aquatic Center Pools. The bid was posted on the Michigan Inter-governmental Trade Network (MITN) website; <a href="www.mitn.info">www.mitn.info</a>. One (1) bid response was received. Below is a detailed summary of potential vendors:

<u>MITN</u> provides a resourceful online platform to streamline the procurement process, reduce costs, and make it easier and more transparent for vendors to do business with the City of Troy.

<u>Active MITN</u> members with a current membership and paying annual dues receive automatic electronic notification which allows instant access to Bids, RFPS and Quote opportunities with the City.

Active MITN non-paying members are responsible to monitor and check the MITN website for opportunities to do business with the City.

Inactive MITN member status can occur when a company does not renew their account upon expiration. Inactive members cannot be notified of solicitations or access any bid information.

### **Purchasing (continued)**

- In addition to this bid opportunity being posted on MITN; the Invitation to Bid was directly emailed to four (4) companies.
- A Pre-Bid meeting was held at all pool sites so potential bidders had the opportunity to view the pools. Two (2) companies were in attendance.
- One (1) bid was received.
- Pool companies that did not respond to this bid opportunity indicated that the City's Scope of Work was too large and the timeline was too short to complete the job.
- Clearwater Pools and Services, Inc. of Ann Arbor, MI is the sole bidder and meets all bid specifications and is being recommended to re-marcite pools and re-grout tiles in pools at the Troy Community Center Pools and Troy Family Aquatic Center Pools.

#### **Financial**

- Funds are budgeted and available for the marciting and re-grouting of the Community Center Pools in the Community Center Buildings and Improvements Annex Renovation Capital Account, Project Number 2020C0042 in the amount of \$80,000.000 for the 2020 Fiscal Year. The total cost of \$52,890.00 will be charged to account number 401.752.755.7975.125, as detailed below.
- Funds are budgeted and available for the marciting and the re-grouting of the TFAC Pools in the Aquatic Center Capital General Equipment Account, Project 2020C0058 in the amount of \$100,000.00 for the 2020 Fiscal Year. The additional \$26,085.00 will require a budget amendment to the Aquatic Center Fund for the 2020 Fiscal Year.

#### **History**

This budget increase for the Engineering Department is due to higher volumes of projects and permits requiring additional outside consultant inspection.
