Do Sanctuary Lake expenses include the cost of the debt service? If so, by how much? Are we still looking to possibly refinance those bonds? (I do know interest rates have risen slightly since last year)

Answers: Rob Maleszyk, City Financial Officer

Yes, as of December, \$81,400 is interest on the debt. It is in the "City Expenses" category. We analyzed the refinancing this past fall and at this point we cannot make enough to do it.

Why are expenses for Sanctuary and Sylvan less than during the same period in the prior year (I know revenues are up due to more rounds played due to Covid)?

Food, alcohol, proshop, and landscaping are all down from the prior year.

Car Washes - \$237.50

Charitable Solicitation - no fee

Film Permits - \$0 (no applications)

There are only a few types of businesses that we require to be licensed that are brick and mortar. Aside from Amusements and Car Washes, the other brick and mortar businesses are of a nature that requires significant inspections and oversight by the Police Department and Code Enforcement. We do not recommend suspending the licensing requirements for these other business types.
