To address a sanitary issue, the City of Troy received a permanent easement for sanitary sewer from William Gadde individually and as trustee of the Revocable Trust Agreement of William Gadde dated March 12, 2014, owner of the property having Sidwell #88-20-18-376-035. The property is located in the southwest ¼ of Section 18.



LEGAL DESCRIPTION - SANITARY EASEMENT #1


