I-07 BUDGET AMENDMENT AND SPR4 H-GAC COOPERATIVE PURCHASE - STORM WATER GLOBAL PUMP

I-10 AWARD SPR8 BEST VALUE AWARD - RETREAT FACILITATOR

After reading through the backup materials, it seems this is essentially contracting a strategic planning team to lock arms with city management on a short-term basis. Correct?

In the past, the strategy discussions produced a list of projects to focus on for that particular budget year, but missing from the deliverable for our residents/stakeholders were the overall/implied ongoing vision/mission/objectives those "strategies" were connected to and supporting. Will the scope of this the final printed deliverable - comprehend those overarching strategic plan components that were missing before?

It is probably easier to discuss this tonight than answer in writing, but I'll do my best. I think your questions focus on the scope of work and how the new process will differ from the old. The short answer is that the facilitation team plans to meet with each City Council member to learn about what you want accomplish during the retreat before they develop the agenda.

In general terms, we are beginning a new process and I emphasize this is just the beginning. City Council could decide to engage in a visioning process or a comprehensive planning process resulting in a vision and mission statement. That may take more time than the current scope of work allows. Initiating such a process might be an objective for the coming year. Alternatively, City Council could decide to focus on the coming budget year or do some of both. In an event, this the beginning of a process City Council gets to define.
