- Subject: Standard Purchasing Resolution 4 Sourcewell Purchasing Cooperative ClearSpan Freestanding Building

<u>History</u>

- The Department of Public Works frequently performs work that involves excavation and requires restoration afterwards.
- The restoration work can only be effective once the ground thaws in the spring.
- Springtime is normally very wet and keeping topsoil in useable condition is nearly impossible when stored uncovered outside.
- When topsoil inventory is wet and unusable, restoration jobs are delayed and residents become frustrated.
- The ClearSpan 42' x 60' Freestanding Building will provide dry storage for topsoil to be readily available to the Department of Public Works staff to provide better service to residents.

<u>Purchasing</u>

- Pricing to provide material, equipment and labor to install one (1) ClearSpan 42' x 60' freestanding building has been secured from *ClearSpan Fabric Structures, Inc of South Windsor, CT* as detailed in the attached quote #1003402 and as per the Sourcewell Purchasing Cooperative Contract # 091319-CSS.
- City Council authorized participation in the Cooperative Purchasing Programs on November 9, 2020 (Resolution #2020-11-165-J-8).
- The ClearSpan Freestanding Building will be installed on pre-cast concrete bin blocks to add height to allow enough room for semi-trucks and loader vehicles to move and operate inside. The bin blocks will be purchased locally by obtaining comparative price quotes as required by the City Charter/Code and will be installed by City staff.

Financial

Funds are budgeted and available in the Streets Buildings and Improvements General Repairs Capital Fund under project number 2022C0031 for the 2022 fiscal year. Expenditures will be charged to account number 401.447.479.7975.900.
