Subject: Standard Purchasing Resolution 4: Sourcewell Cooperative Purchasing Contract –

Storage Area Network (SAN), Installation and Configuration

History

In 2016, the Information Technology Department purchased a Hewlett Packard Enterprise 3PAR StoreServe 8200 Storage Area Network a Storage Area Network (SAN) device and related peripherals with an approximate capacity of 25.8 TB (Resolution #2016-12-212-J-4a). This system was used to store all data related to the virtual hosts and guests. Having the storage separate from the physical server allowed easier upgrade and management of each. Pooling storage allows for better storage utilization by dynamically allocating what is needed for each server. The SAN also has redundant drives, controllers, and power supplies making it incredibly resilient. In addition, the ability to virtualize servers on the SAN allows for server failover.

The City's data usage on the existing SAN is currently growing at a rate of approximately 1.5 TB per year. That could increase depending on any new applications that may be implemented and as we continue to move more paper documents to the Document Management System.

The current system is now 8 years old and has become increasingly more difficult to locate replacement drives. The newer systems now offer features that would make management and use of the SAN much more efficient:

- New SAN offers a 5:1 compression capacity not available on the current SAN.
- Updated fiber switches with double the previous cache.
- Faster and increased cache sizes. As a result, data accessed most often is presented much more quickly.

History (continued)

Management has been pleased with the performance and reliability of Hewlett Packard products and proposes to purchase the Hewlett Packard Enterprise HPE ALLETRA 5000. It would be configured as follows:

- Forty-two (42) TB capacity expandable to two hundred ninety-four (294) TB
- Four (4) TB Cache for faster data retrieval
- Two (2) 32GB fiber channel switches
- · Related software and licenses
- Installation and configuration
- 5 years of Maintenance
- Training

The new SAN will have a total capacity of approximately 42TB for a total cost of \$80,638.68.

Purchasing

- Pricing for the Hewlett Packard Enterprise SAN has been secured from CDW-G of Vernon
 Hills, IL through the Sourcewell Cooperative Purchasing Contract #081419 as detailed in the
 attached quote PBCW592 dated August 6, 2024.
- On February 5, 2024 City Council authorized participation in the Cooperative Purchasing Programs (Resolution # 2024-02-031-J-5).

Financial

Funds are budgeted and available in the Information Technology Capital Fund under Project Number 2025C0049 for the fiscal year 2025. Expenditures will be charged to account number 636.228.980.020.

Recommendation

City Management requests a contract be awarded to *CDW-G of Vernon Hills, IL* for the purchase of the HPE ALLETRA 5000 SAN, implementation and five (5) years of maintenance as detailed in the attached quote utilizing the Sourcewell Cooperative Purchasing Program for an estimated total cost of \$80,638.68.
