Subject: Standard Purchasing Resolution 4: State of Michigan MiDEAL Cooperative Purchase -

Motorola Radio System Hardware

History

In June of 2019 Oakland County signed a \$46.9 million contract with Motorola Solutions to be the replacement radio system provider, to include all required infrastructure for the County, and is funded through the 911 Surcharge and bonds. Subsequently, a survey was conducted in 2019 of all Oakland County police/fire departments, to develop a subscriber unit allocation matrix that would be supported by the project funding. Based on the results of the survey conducted, and the allocation matrix developed by Oakland County, the Troy Fire Department is to receive approximately \$1.08 million in radios and accessories including: 96 Portable Radios; 39 Mobile Radios; and 6 Control Stations. This left the TFD with an initial deficit of: 29 Portable Radios; 6 Mobile Radios; and 1 Control Station; which due to our deployment model, would have a significant impact on fireground operations. In August of 2021, City Council approved the purchase of additional radios and equipment (Resolution #2021-08-131-J-4c). While this purchase increased the equipment allocation it still left the TFD short radios, however would provide for the initial rollout of the new OCP25 radio system and provide basic operations. The new OCP25 radio system went live in November of 2023. After 8 months of daily use, an internal review of our equipment was conducted to evaluate our deployment, taking into consideration firefighter safety, incident management & mitigation as well as fiscal responsibility. The TFD has identified additional equipment is required to maintain continuity of operations, resulting in an additional purchase of: 4 Portable Radios; 1 Control Station; and miscellaneous chargers, batteries and microphones.

Purchasing

- Pricing for the purchase of additional radios, microphones, and batteries has been secured from *Motorola Solutions, Inc. of Schaumburg, IL* per the MiDEAL Cooperative Contract 19000001544, as detailed in quotation #2745495, dated August 9, 2024.
- City Council authorized participation in the Cooperative Purchasing Programs on February 5, 2024 (Resolution #2024-02-031-J-5).

Financial

Funds for this project are budgeted and available in the Fire Department Capital Fund under Project Number 2025C0012 for the 2025 fiscal year. Expenditures will be charged to account number 401.336.343.978.020, General Equipment Communications.

Recommendation

City Management recommends a contract be awarded to *Motorola Solutions, Inc. of Schaumburg, IL*, for the procurement of additional radios, microphones, and batteries for the Troy Fire Department, for an estimated total cost of \$42,723.17, as detailed in the attached quote and as per the MiDEAL Cooperative Contract 190000001544; not to exceed budgetary limitations.
