The systems incorporated combining training rooms, a presentation stage, video signage for the employee dining area and snack bar, and a welcoming 3 X 5 HD video wall.

The training rooms reside behind glass walls and surround the dining area. The entire location is designed for both open collaboration and small huddles to large group presentations. This entire meeting area is called the HUB. Four of the larger rooms are divisible through Creston DMPS300 router/controllers. ClickShare is utilized in the rooms for wireless presentations.

Also located within this area are multiple signage displays. Each of these displays is assigned a different message including corporate promotions, local origination and a clever depiction of a United States map showing the number of pizza orders in real time, by location. Content is routed through a 16x16 digital router to feed the video wall and is controlled via wireless tablet through a graphical user-interface. This warranty/support agreement begins on the date of *installation* completion. Installation completion may comprise a functioning part of the system, or the entire system. The scope of this completed portion of the system is described under the Special Conditions portion of this contract.

The system completion date is determined by Tel Systems, and acknowledged by the customer in writing by signing this contract and initiating the warranty. If the customer contends that the system (or portion in question) is not complete at the time of system completion, then a list of outstanding issues is created by the customer, or Tel Systems, and the issues are addressed.

If the customer fails to sign the System Completion acknowledgement form after the issues are addressed, then the system warranty is initiated at the time of initial invoicing for any unit in question.

### **WARRANTY AUTHORIZATION CODE:**

A warranty authorization code number is assigned to a customer representative at the initiation of the warranty/support program. This customer representative has the authority to initiate billable service calls. By providing the WAC # over the phone when a service call is desired, the customer authorizes the following:

1. Authorizes the Tel Systems service department to begin the work.
2. Authorizes the Tel Systems service department to invoice the customer for work not covered under the warranty.

### **WARRANTY/SUPPORT CLAIM PROCEDURE:**

To initiate a claim, the customer will call the Tel Systems service department, and simply state their Warranty Authorization Code (WAC) number to the service representative. Upon verification of the WAC #, the Tel Systems service coordinator will identify the system, the specific warranty and support package assigned to the customer, and initiate a trouble ticket for future tracking. The Tel Systems service coordinator determines a course of action once the complaint is understood.

The service representative can attempt to troubleshoot the problem on the phone, or escalate the trouble ticket to the service supervisor, systems designer, engineering manager, technician, or installation manager for telephone diagnostics and troubleshooting. This may require a return phone call to the customer.

Upon troubleshooting on the phone, it may be determined that a technician be dispatched to the site. This is done at a mutually agreed upon time between the customer and the Tel Systems service center.

The equipment in question may need to be removed from the system by a Tel Systems technician and brought back to the Tel Systems service center, or returned to the vendor for factory service, or the equipment or system may be repaired on site. If the equipment is removed, Tel Systems will re-install the equipment on the return visit.



### History

- It is expected that the new equipment will last 15 – 20 years.

### Purchasing

- This exclusion applies even if the claims against any insured allege negligence or other wrongdoing in the supervision, hiring, employment, training or monitoring of others by that insured, if the "occurrence" which caused the "bodily injury" or "property damage" or the offense which caused the "personal and

advertising injury" involved the rendering of or failure to render any professional services by or for you.

- d. With respect to the insurance afforded to these additional insureds, the following is added to **SECTION III - LIMITS OF INSURANCE**:

- b. This coverage does not apply if **COVERAGE C – MEDICAL PAYMENTS** is excluded either by the provisions of the Coverage Part or by endorsement.

#### 9. Newly Acquired Or Formed Organizations

**SECTION II – WHO IS AN INSURED**, Paragraph 3.a. is replaced by the following:

- a. Coverage under this provision is afforded until the end of the policy period.

#### 10. Non-Owned Watercraft

**SECTION I – COVERAGES, COVERAGE A BODILY INJURY AND PROPERTY DAMAGE LIABILITY**, Paragraph 2. **Exclusions**, subparagraph g.(2) is replaced by the following:

##### g. Aircraft, Auto Or Watercraft

- (2) A watercraft you do not own that is:

- (a) Less than 51 feet long; and
- (b) Not being used to carry persons or property for a charge;

This provision applies to any person who, with your consent, either uses or is responsible for the use of a watercraft.

#### 11. Supplementary Payments Increased Limits

**SECTION I – SUPPLEMENTARY PAYMENTS COVERAGES A AND B**, Paragraphs 1.b. and 1.d. are replaced by the following:

- 1.b. Up to \$2,500 for cost of bail bonds required because of accidents or traffic law violations arising out of the use of any vehicle to which the Bodily Injury Liability Coverage applies. We do not have to furnish these bonds.

- 1.d. All reasonable expenses incurred by the insured at our request to assist us in the investigation or defense of the claim or "suit", including actual loss of earnings up to \$1000 a day because of time off from work.

#### 12. Unintentional Failure to Disclose Hazards

The following is added to **SECTION IV – COMMERCIAL GENERAL LIABILITY CONDITIONS**, Paragraph 6. **Representations:**

We will not disclaim coverage under this Coverage Part if you fail to disclose all hazards existing as of the inception date of the policy provided such failure is not intentional.

#### 13. Unintentional Failure to Notify

The following is added to **SECTION IV – COMMERCIAL GENERAL LIABILITY CONDITIONS**, Paragraph 2. **Duties in the Event of Occurrence, Offense, Claim or Suit:**

Your rights afforded under this policy shall not be prejudiced if you fail to give us notice of an "occurrence", offense, claim or "suit", solely due to your reasonable and documented belief that the "bodily injury" or "property damage" is not covered under this policy.

ALL OTHER TERMS, CONDITIONS, AND EXCLUSIONS REMAIN UNCHANGED.

- b. The insurance afforded to such vendor described above:
  - (1) Only applies to the extent permitted by law;
  - (2) Will not be broader than the insurance

which you are required by the contract or agreement to provide for such vendor;

- (3) Will not be broader than coverage provided to any other insured; and
- (4) Does not apply if the "bodily injury", "property damage" or "personal and advertising injury" is otherwise excluded from coverage under this Coverage Part, including any endorsements thereto
- c. With respect to insurance afforded to such vendors, the following additional exclusions apply:

## ADDITIONAL INSURED – PRIMARY AND NON-CONTRIBUTORY

This endorsement modifies insurance provided under the following:

### COMMERCIAL GENERAL LIABILITY COVERAGE PART

The following is added to **SECTION IV – COMMERCIAL GENERAL LIABILITY CONDITIONS, Paragraph 4. Other Insurance:**

#### Additional Insured – Primary and Non-Contributory

If you agree in a written contract, written agreement or permit that the insurance provided to any person or organization included as an Additional Insured under **SECTION II – WHO IS AN INSURED**, is primary and non-contributory, the following applies:

If other valid and collectible insurance is available to the Additional Insured for a loss we cover under Coverages **A** or **B** of this Coverage Part, our obligations are limited as follows:

#### (1) Primary Insurance

This insurance is primary to other insurance that is available to the Additional Insured which covers the

Additional Insured as a Named Insured. We will not seek contribution from any other insurance available to the Additional Insured except:

- (a) For the sole negligence of the Additional Insured;
- (b) When the Additional Insured is an Additional Insured under another primary liability policy; or
- (c) When (2) below applies.

If this insurance is primary, our obligations are not affected unless any of the other insurance is also primary. Then, we will share with all that other insurance by the method described in (3) below.

#### (2) Excess Insurance

- (a) This insurance is excess over any of the other insurance, whether primary, excess, contingent or on any other basis:
  - (i) That is Fire, Extended Coverage, Builder's Risk, Installation Risk or similar coverage for "your work";
  - (ii) That is Fire insurance for premises rented to the Additional Insured or temporarily occupied by the Additional Insured with permission of the owner;
  - (iii) That is insurance purchased by the Additional Insured to cover the Additional Insured's liability as a tenant for "property

damage" to premises rented to the Additional Insured or temporarily occupied by the Additional with permission of the owner; or

- (iv) If the loss arises out of the maintenance or use of aircraft, "autos" or watercraft to the extent not subject to Exclusion g. of **SECTION I – COVERAGE A – BODILY INJURY AND PROPERTY DAMAGE LIABILITY.**

- (b) When this insurance is excess, we will have no duty under Coverages **A** or **B** to defend the insured against any "suit" if any other insurer has a duty to defend the insured against that "suit". If no other insurer defends, we will undertake to do so, but we will be entitled to the insured's rights against all those other insurers.

- (c) When this insurance is excess over other Insurance, we will pay only our share of the amount of the loss, if any, that exceeds the sum of:

- (i) The total amount that all such other insurance would pay for the loss in the absence of this insurance; and
- (ii) The total of all deductible and self insured amounts under all that other insurance.

We will share the remaining loss, if any, with any other insurance that is not described in this Excess Insurance provision and was not bought specifically to apply in excess of the Limits of Insurance shown in the Declarations of this Coverage Part.

#### (3) Method Of Sharing

- (a) If all of the other insurance permits contribution by equal shares, we will follow this method also. Under this approach each insurer contributes equal amounts until it has paid its applicable limit of insurance or none of the loss remains, whichever comes first.
- (b) If any of the other insurance does not permit contribution by equal shares, we will contribute by limits. Under this method, each insurer's share is based on the ratio of its applicable limit of insurance to the total applicable limits of insurance of all insurers.

ALL OTHER TERMS, CONDITIONS, AND EXCLUSIONS REMAIN UNCHANGED.
