### To All Bidders:

Please be advised that the City of Troy Purchasing Department has authorized the following ANSWERS TO QUESTIONS regarding Bid Proposal **ITB-COT 19-31**, **Holiday Lights.** The CHANGES will be considered an integral part of the original proposal documents.

### Clarifying questions:

QUESTION: Approximately, when is the bid awarded?

**ANSWER:** A Purchase Order will be issued upon City Council approval. It is the City's intent to take the recommendation to City Council for approval at either the July 22<sup>nd</sup> or August 8<sup>th</sup> meeting.

QUESTION: Is the Cashier's Check, bid bond, made out to the City of Troy?

**ANSWER:** As per the Bid Specifications detailed below Bid bonds are not accepted. Include a cashier's check, certified check or money order payable to the City of Troy.

A cashier's check, certified check, or money order in the **amount of \$2,250.00** must accompany the bid to insure the bid. **BID BONDS ARE NOT ACCEPTABLE**. The bid deposit of the successful bidder will be retained as performance surety until successful completion and acceptance of all contract requirements. The bid surety will be forfeited, if acceptable insurance is not received in accordance with specifications. All other bidders will have their bid deposits returned after the bid has been opened for at least 72 hours.

**QUESTION:** What sort of permit do we need to work on Sunday? And where do we get it? **ANSWER:** It is just a work permit allowing you to work on Sunday. There would be no cost involved as you are performing work for the City of Troy. The City would assist you in getting the permit from the building department.

QUESTION: Project needs to be done by November 15, but when can we start?

**ANSWER:** Typically the awarded contractor would start about Nov. 1st. Although, note last year the awarded contractor started later. The install takes approximately a week to complete.

**QUESTION:** There are approximately 4,000+ strands of lights. Are they rolled neatly into approximately 65 18 gallon totes? Do ALL the lights work? If they don't work what is the replacement procedure and what sort of delays could we expect? What is the approximately length of each strand (important)? Are the lights LEDS?

**ANSWER:** The lights are currently stored on reels. The City of Troy believes that all the lights work. If there is a need for replacement there are replacement strands at the Department of Public Works. The strands are 17' in length and have approximately 50 LED lights per strand.

**QUESTION:** Safety barrier clarification - the "Island of trees" that we are working at - we have to barricade that off?

**ANSWER:** The contractor is required to make sure that your staff is protected by following the required rules and regulations. The awarded contractor is required to follow all rules and regulations regarding traffic.

**QUESTION:** Are all the outlets in good working condition? Does the City of Troy ensure that those are ON during time of install?

**ANSWER**: All outlets are in working condition and are on all the time. If the contractor comes to a receptacle that is not working they will notify the City and the City will have it repaired.

**QUESTION**: Any idea how long it has taken contractors to complete the full job in the past? **ANSWER**: This year and last year it took approximately 1 weeks' time (weather related).

QUESTION: Did they all use poles, ladders, etc. with no cherry lift?

**ANSWER:** The contractors have used both poles and ladders. Lifts have been utilized from the turn lanes on occasion.

QUESTION: Can the City provide some further detail on proposal B?

**ANSWER:** What the cost per tree would be should the City of Troy desire to add additional trees at any location.

QUESTION: Would the awarded Contractor provide all the additional material in that instance?

ANSWER: The City would provide the additional lights if required.

QUESTION: Does the City desire swirled or branch wrapping of the trees?

ANSWER: The City desires Swirling.

**QUESTION:** What kind of trees are they?

ANSWER: The trees are various evergreen and/or deciduous.

QUESTION: How tall and wide are the trees?

**ANSWER:** The trees vary in size; short or tall, narrow or wide. It is encouraged to visit the site of the install. Note, that this question is in reference to Proposal B. 

- C. The limits of insurance applicable to the additional insured are those specified in the written contract or in the Declarations for this Coverage Form, whichever are less. If no limits are specified in the written contract, the limits applicable to the additional insured are those specified in the Declarations for this Coverage Form. These limits of insurance are inclusive of and not in addition to the limits of insurance shown in the Declarations.
- D. Section IV Commercial General Liability Conditions, 4., Other Insurance is amended to include:

Coverage provided by this endorsement is excess over any other valid and collectible insurance available to the additional insured whether the other insurance is primary, excess, contingent or on any other basis unless the written contract between you and the additional insured requires this insurance to be primary.
